On August 4, 2014, F-4428-14-JE was electronically posted on the City's website, advertised and sent to 911 firms on Bidsync.com in accordance with the City's Purchasing Ordinance, Section 38.42 (A) (1), was opened at 3:00 P.M. on August 28, 2014, and resulted in responses from four (4) bidders, all of which fully meet all terms and conditions of the bid requirements.

- Henry Schein, Inc.; Melville, New York
- Municipal Emergency Services, Inc.; Charlotte, North Carolina
- Ten-8 Fire Equipment, Inc.; Bradenton, Florida

After evaluation of all bids, the Fire Chief and the Director of Procurement Services recommend to make the award to the vendors offering the best discount by manufacturer, for a three (3) year term, with the options to renew for two (2) additional one (1) year period under the same terms, conditions and firm discounts as the original award, subject to vendor acceptance and the determination by the City Commission that renewal will be in the best interest of the City. The City has been doing business with the above vendors for many years with satisfactory results.

The City reserves the right to accept and award item by item, and/or by group, and designate one or more contractors as the Primary or Secondary Vendor(s) for the delivery of material and/or Services through the effective period of the award. Further, in any situation where obtaining Services from the Primary Vendor(s) is not in the best interest of the City, or the vendor cannot deliver material and/or Services within twenty-four (24) hours of the date required, or on an emergency basis, staff may obtain Services from the Secondary Vendor(s).

The anticipated expense for these Blanket Purchase Orders for the first twelve (12) months is \$60,000.00, which funding been provided for in the fiscal year 2015 budget in the Fire Rescue and Beach Safety Department Account Number 01.2151.00000.522.005216 and will be requested and budgeted in subsequent fiscal years contingent upon the approval and adoption of each subsequent Fiscal Year Budget.
