WHEREAS, the completion of the audit for Fiscal Year 2015 allows for the reconciliation of budgeted amounts of net assets to actual audited amounts;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1:</u> That the Amendments to the Operating Budget of the City of Hollywood for the Fiscal Year beginning October 1, 2015, as set forth in detail in Exhibits 1 and 2, attached hereto, and by this reference made a part hereof, are hereby approved, adopted and accepted as Amendments to the Operating Budget of the City of Hollywood Florida, for the Fiscal Year 2016.

<u>Section 2:</u> That the Department of Financial Services is hereby authorized to establish such line item accounts as may be necessary to properly monitor and track expenditures.

<u>Section 3:</u> That this resolution shall be in full force and effect immediately upon its passage and adoption.
