FIRST AMENDMENT TO INTERLOCAL AGREEMENT FOR GUARANTEED PARTIAL SERVICE BUILDING CODE SERVICES TO BE PROVIDED BY THE BROWARD COUNTY BUILDING CODE SERVICES DIVISION OF THE ENVIRONMENTAL PROTECTION

AND GROWTH MANAGEMENT DEPARTMENT

This First Amendment to Interlocal Agreement is made and entered into between: Broward County, a political subdivision of the state of Florida, hereinafter referred to as "County,"

and

City of Hollywood, a municipal corporation existing under the laws of the state of Florida, hereinafter referred to as "City" (collectively referred to as the "Parties").

- A. City and County entered into that certain Interlocal Agreement that was executed by County on May 23, 2019 ("Agreement"), pursuant to Section 163.01, Florida Statutes, also known as the "Florida Intergovernmental Cooperation Act of 1969," whereby City procured the services of County for the performance of building official, plan review, permit inspections, code enforcement, and other services related to the Florida Building Code.
- B. The Agreement commenced on April 1, 2019, and shall remain in full force and effect until midnight April 1, 2022. The Agreement provides for renewal for an additional five (5) year period upon request of City and approval by the County Administrator.
- C. On September 28, 2021, City submitted its written request to renew the Agreement for an additional five (5) year period.
- D. County is agreeable to renewing the Agreement for one (1) five (5) year period.

Now, therefore, in consideration of the mutual covenants, promises, and representations herein, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

- The Recitals contained above are true and correct, form a material part of this First Amendment upon which the Parties have relied, and are incorporated by reference.
- 2. Paragraph 4.1 of the Agreement is hereby amended to read as follows:
 - 4.1. This Agreement shall commence on April 1, 2019, and shall continue in full force and effect until midnight April 1, 2022 April 1, 2027. Unless terminated as provided in Article 7, TERMINATION, this Agreement may be renewed for an additional five (5) year period upon request of CITY and approval of COUNTY, as provided in Section 9.6.
- 3. Except as amended herein, all of the terms, conditions, and provisions of the Agreement shall remain in full force and effect.
- 4. In the event of any conflict of ambiguity by and between the terms and provisions of this First Amendment and the Agreement, the terms and provisions of this First Amendment shall control to the extent of any such conflict.
- 5. This First Amendment shall be recorded in the public records of Broward County at City's expense.
