A RESOLUTION OF THE CITY COMMISSION OF THE CITY
OF HOLLYWOOD, FLORIDA, APPOINTING FOUR
MEMBERS TO THE ARTWORK SELECTION COMMITTEE.

WHEREAS, the City's Artwork Selection Committee ("Committee") was created in June 1994 to review, select and display appropriate artwork, including photography, loaned or donated to the City for exhibition on the walls of the foyers and corridors of City Hall at 2600 Hollywood Boulevard, Hollywood, Florida; and

WHEREAS, the duties of the expanded Committee include reviewing artwork that could be acquired by the City through commission, donation, or purchase for placement within City facilities; and

WHEREAS, Resolution R-2018-171 was amended to increase the membership of the Committee from nine to ten members, including a student member; and

WHEREAS, the Committee is comprised of members who are from the artistic and cultural community, are associated with artists in various media in Florida, and have leadership in numerous cultural organizations, which is an essential component when selecting board members to attract new talent to City Hall; and

WHEREAS, presently Sara Berke, Lisa Gangadeen and Bram Scolnick serve on the Committee, and their terms expire on June 30, 2019; and

WHEREAS, Graham Rubin currently serves as a Youth Member and his term expires on June 30, 2019; and

WHEREAS, the City Clerk provided notice to the public that positions were available and solicited interest forms from the community to fill the current vacancies; and

WHEREAS, the following individuals have expressed a desire and willingness to fill the vacancies and serve on the Committee:

WHEREAS, no applications were submitted for student member.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:
