A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE THE ATTACHED BLANKET PURCHASE ORDER RENEWING THE AGREEMENT BETWEEN HARCROS CHEMICALS, INC. AND THE CITY OF HOLLYWOOD FOR THE SUPPLY AND BULK DELIVERY OF HYDROFLUOSILICIC ACID (FLUORIDE) IN AN ESTIMATED AMOUNT OF \$91,000.00

WHEREAS, the Department of Public Utilities Water Treatment Plant wishes to renew the agreement for the supply and bulk delivery of hydrofluosilicic acid (fluoride) for use at the Water Treatment Plant as a tooth decay preventative in growing children; and

WHEREAS, the required hydrofluosilicic acid (fluoride) was competitively bid by the City of Ft. Lauderdale, as lead agent for the Southeast Florida Governmental Purchasing Cooperative Group, of which the City of Hollywood is a participant; and

WHEREAS, the City of Ft. Lauderdale's Bid Number 432-11261 was opened on September 25, 2013 and was awarded to the lowest responsive, responsible bidder, Harcros Chemicals, Inc. of Tampa, Florida on November 5, 2013 for a one (1) year agreement with the option to renew for three (3) additional one (1) year periods; and

WHEREAS, the City Commission of the City of Hollywood, Florida, at its meeting of May 7, 2014, via Resolution Number R-2014-107, authorized the issuance of a blanket purchase for the initial one (1) year period for the purchase of hydrofluosilicic acid (fluoride) to the lowest responsible bidder, as awarded by the City of Ft. Lauderdale, Florida to Harcros Chemicals, Inc.; and

WHEREAS, Harcros Chemicals, Inc. is currently providing this product to the City in a satisfactory manner; and

WHEREAS, the Director of Procurement Services is authorized to join with other governmental entities in cooperative purchasing plans as per the City's Purchasing Ordinance, Section 38.46; and

WHEREAS, the Director of Public Utilities and the Director of Procurement Services recommend that the City Commission approve the issuance of the attached Blanket Purchase Order renewing the agreement for the Supply and Bulk Delivery of

Hydrofluosilicic Acid (Fluoride) to Harcros Chemicals, Inc. of Tampa, Florida for the first one (1) year renewal period in an estimated annual amount of \$91,000.00; and

WHEREAS, award is subject to the City's receipt and approval of all insurance certificates required by the City's Risk Manager; and

WHEREAS, funding for the attached blanket purchase order has been provided for in the fiscal year 2015 budget in the Water Treatment Plant's Chemical Supply Account Number 42.4011.00000.536.005233 or in the Fluoride Grant Project Account Numbers 42.4000.31713.536.006301 and 42.4000.31713.536.016301, and funding will be budgeted in subsequent fiscal years;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That it hereby approves and authorizes the issuance, by the appropriate City Officials, of the attached Blanket Purchase Order between Harcros Chemicals, Inc. and the City of Hollywood, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legality by the City Attorney.

Section 2: That this resolution shall be in full force and effect immediately upon its passage and adoption.
