A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, REPEALING RESOLUTION NOS. R-2008-231, R-2011-129 and R-2011-213 RELATING TO THE RATE SCHEDULE OF FEES AND CHARGES FOR THE DEPARTMENT OF PARKS RECREATION AND CULTURAL ARTS; AND APPROVING THE ESTABLISHMENT OF A NEW RATE SCHEDULE AND FEE STRUCTURE AS MORE SPECIFICALLY SET FORTH IN EXHIBIT "A".

WHEREAS, currently the Department of Parks, Recreation and Cultural Arts rate schedule and fees are spread out among several Resolutions previously passed and adopted by the City Commission; and

WHEREAS, City staff has reviewed the multiple resolutions for the Department of Parks, Recreation and Cultural Arts rate schedule and fees and has determined that in order to minimize confusion and simplify the process for those users of the Department's various facilities, activities and programs, the establishment of a new cohesive rate schedule and fee structure should be established; and

WHEREAS, staff has surveyed surrounding municipalities to obtain the prevailing fees and rates, and has found that the City's fees need to be updated and adjusted in several service areas; and

WHEREAS, it has been determined that many of the surveyed agencies use a range rate when dealing with golf and marina fees, based on their dependence on many variables that can change quickly throughout the year such as weather, economic climate and facility capacity; and

WHEREAS, the Department has also determined that several fees that have not been used in many years should be eliminated and/or replaced by more equitable fees as based on similar fees charged by surrounding municipalities ; and

WHEREAS, the Department of Parks, Recreation and Cultural Arts (PRCA) has, from time to time, proposed changes to the various fees in order to help recover a portion of the expenses budgeted annually which supports the PRCA's current recreation programs and events; and

WHEREAS, the last Recreation rate increase approved by the City Commission was in September 2011 pursuant to Resolution No. R-2011-213; and

WHEREAS, the last Marina rate increase approved by the City Commission was in July 2008 pursuant to Resolution No. R-2008-231; and

WHEREAS, the last Golf rate increase approved by the City Commission was in June 2011 pursuant to Resolution No. R-2011-129; and

WHEREAS, the streamlined fee structure will be more customer friendly and will help supplement the City's allocation of General Fund dollars for various programs and services within PRCA;

NOW, THEREFORE, BE IT RESOLVED, BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That it hereby repeals Resolution Nos. R-2008-231, R-2011-129 and R-2011-213.

Section 2: That is hereby approves and authorizes the adoption of the rate schedule and fees for those facilities, activities, and programs as more specifically set forth in Exhibit "A" attached hereto and incorporated herein by reference.

Section 3: That all other fees and charges set forth in the rate schedule established in Resolution Nos. R-2008-231, R-2011-129 and R-2011-213 shall remain in full force and effect.

Section 4 That all fees established by this Resolution shall be further amended on each October 1, starting in 2018, by the annual increase in the Consumer Price Index for all Urban Consumers in the Miami-Fort Lauderdale Metropolitan Area as of the previous June.

Section 5: That this Resolution shall be in full force and effect as immediately upon its passage and adoption.
