

ORDINANCE NO. _____

AN ORDINANCE OF THE CITY OF HOLLYWOOD, FLORIDA, AMENDING ORDINANCE O-2018-18 OF THE CODE OF ORDINANCES, WHICH REPEALED THE REGULATIONS RELATING TO PROVISIONAL PARKING LOTS WITHIN THE DOWNTOWN AND BEACH DISTRICTS OF THE COMMUNITY REDEVELOPMENT AGENCY, TO REVISE SECTION 4 OF ORDINANCE NO. O-2018-18 TO EXTEND THE TIMEFRAME FOR PROVISIONAL PARKING LOTS WITHOUT PERMITS TO CEASE AND DESIST ON SEPTEMBER 30, 2019, OR 30 DAYS FROM THE COMPLETION DATE OF THE NEBRASKA STREET PARKING GARAGE, WHICHEVER IS EARLIER.

WHEREAS, on November 7, 2018, the City Commission passed and adopted Ordinance No. O-2018-18, which amended Section 157.78 of the Code of Ordinances, entitled "Minimum Maintenance Standards", to repeal the regulations relating to provisional parking lots within the Downtown and Beach Districts of the Community Redevelopment Agency; and

WHEREAS, as part of the repeal relating to provisional parking lots, the City Commission determined that those provisional parking lots that are without permits should cease and desist operations within 90 days of the effective date of Ordinance No. O-2018-18; and

WHEREAS, at its February 20, 2019 City Commission meeting, Commissioners Shuham, Callari and Mayor Levy requested that Section 4 of Ordinance No. O-2018-18 be amended to allow those provisional parking lots that are without permits to continue operations until September 30, 2019, or 30 days from the completion date of the Nebraska Street Parking Garage, whichever is earlier.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Ordinance.

Section 2: That Section 4 of Ordinance No. O-2018-18 shall be amended to read as follows:

(Coding: Words in ~~struck through~~ type are deletions from existing text; words underscored are additions to existing text.)

That all other provisional parking lots without permits must cease and desist operations by September 30, 2019, or 30 days from the completion date of the Nebraska Street Parking Garage, whichever is earlier. ~~Within 90 days of the effective date of this Ordinance.~~

Section 3: That all other provisions and Sections of Ordinance No. O-2018-18 shall remain in full force and effect.

Section 4: That it is the intention of the City Commission that the provisions of this Ordinance shall become and be made a part of the Code of Ordinances of the City of Hollywood, Florida, and the provisions of this Ordinance may be renumbered to accomplish such intention.

Section 5: That if any word, phrase, clause, subsection or section of this Ordinance is for any reason held unconstitutional or invalid, such invalidity shall not affect the validity of any remaining portions of this Ordinance.

Section 6: That all sections or parts of sections of the Code of Ordinances, all ordinances or parts of ordinances, and all resolutions or parts of resolutions in conflict are repealed to the extent of such conflict.

Section 7: That this Ordinance shall be in full force and effect immediately upon its passage and adoption.
