A RESOLUTION OF THE CITY COMMISSION OF THE
CITY OF HOLLYWOOD, FLORIDA, APPOINTING FOUR
MEMBERS TO THE AFFORDABLE HOUSING ADVISORY
COMMITTEE.

WHEREAS, pursuant to Section 420.9076, Florida Statutes, the City is required to create an Affordable Housing Advisory Committee; and

WHEREAS, Section 160.06 of the Hollywood Code of Ordinances created the City's Affordable Housing Committee in accordance with State law; and

WHEREAS, the Affordable Housing Advisory Committee ("Committee") shall recommend specific actions or initiatives to encourage or facilitate affordable housing while protecting the ability of property to appreciate in value; and

WHEREAS, the Committee shall consist of one elected official and no more than 11 members with specific occupational and/or public service disciplines; and

WHEREAS, members shall serve for three-year terms and may be reappointed for subsequent terms pursuant to Chapter 37 of the Hollywood Code of Ordinances, and

WHEREAS, there are four vacant positions due to two positions not being filled, the resignation of Bernard Isler and the removal of Dameka Davis; and

WHEREAS, the City Clerk provided notice to the public that positions are available and solicited interest forms from citizens to fill available vacancies; and

WHEREAS, the following individuals have expressed a desire and willingness to fill these vacancies and serve on the Committee:
