A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE A DISTRICT FOUR HIGHWAY MAINTENANCE MEMORANDUM OF AGREEMENT FOR THE SOUTHBOUND LANE OF NORTH 22ND AVENUE FROM SHERIDAN STREET TO STIRLING ROAD.

WHEREAS, the Broward County Metropolitan Planning Organization (“MPO”) prioritized and awarded funding to the Cities of Hollywood and Dania Beach for the design and construction of improvements identified on the attached Exhibit “A” (within Exhibit “1”), referred to as “the Project”, along 22nd Avenue from Sheridan Street to Stirling Road, pursuant to the “2022 Complete Streets/Localized Initiatives Program” (“CSLIP”); and

WHEREAS, the southbound lane of North 22nd Avenue is within the City limits; and

WHEREAS, the MPO requires the City’s commitment to maintain all improvements made as part of the Project and in accordance with Title 23 U.S. Code Section 116 and Federal Highway Administration regulations; and

WHEREAS, pursuant to Sections 339.07, 339.08 and 339.12, Florida Statutes and Federal funding provisions the Florida Department of Transportation (“FDOT”) is authorized to undertake projects within the City’s geographical limits, and the City agrees to engage FDOT to construct the Project; and

WHEREAS, the City and the FDOT recognize the need for entering into a District Four, Highway Maintenance Memorandum of Agreement (“Agreement”), attached as Exhibit “1”; and

WHEREAS, funding for the Project is fully guaranteed through the CSLIP grant agreement with an estimated construction cost of \$3,500,000.00 paid by Broward County Metropolitan Planning Organization (“MPO”); and

WHEREAS, maintenance of the landscape improvements will commence upon completion of the installation, which is anticipated to be FY 2026, and maintenance funds will be requested in future fiscal years.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the execution, by the appropriate City officials, of the attached Agreement for roadway improvements along southbound lane of North 22nd Avenue from Sheridan Street to Stirling Road.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
