A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE A PURCHASE ORDER TO GLADE & GROVE SUPPLY CO, LLC FOR THE PURCHASE OF A NEW HOLLAND AGRICULTURAL TRACTOR MODEL TS6.120 HC W/BEACH TIRES IN AN AMOUNT UP TO \$122,680.86 BASED UPON SOURCEWELL-AGRICULTURAL EQUIPMENT CONTRACT #082923-CNH-2 IN ACCORDANCE WITH SECTION 38.41(C)(5) OF THE PROCUREMENT CODE. (PIGGYBACK)

WHEREAS, the Department of Public Works desires to purchase New Holland Agricultural Tractor model TS6.120 HC w/Beach Tires that will be used to remove large amounts of seaweed, grooming, and refining the sand and general upkeep of the beach; and

WHEREAS, the desired purchase New Holland Agricultural Tractor model TS6.120 HC w/Beach Tires was competitively bid by Sourcewell-Agricultural Equipment Solicitation Number: RFP #082923 on July 11, 2023, and awarded to CNH Industrial America LLC under contract Sourcewell-Agricultural Equipment #082923 CNH-2; and

WHEREAS, the current term of Sourcewell-Agricultural Equipment #082923-CNH-2 is from November 13, 2023 through October 11, 2027, with an option to renew the contract for three additional one-year extensions; and

WHEREAS, CNH Industrial America LLC has agreed to extend to the City the same pricing under the terms and conditions set forth in Sourcewell-Agricultural Equipment Contract #082923-CNH-2; and

WHEREAS, Glade & Grove Supply Co, LLC ("Glade & Grove") is an authorized dealership for CNH Industrial America LLC under the Sourcewell-Agricultural Equipment Contract #082923-CNH-2; and

WHEREAS, Section 38.41(C)(5) of the Procurement Code allows the Chief Procurement Officer to procure, without formal solicitation procedures, all goods, supplies, materials, equipment, and services that are the subject of contracts with the state, its political subdivisions, the United States government, other governmental entities, or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof ("piggyback"), provided that the goods, supplies, materials, equipment, or services are the subject of a price schedule negotiated by the entities listed above and is based strictly on competitive bids, quotations, or competitive proposals and not on any preference

and such utilization of other governmental entities contracts shall be permitted only during the term of the other governmental entity's contract; and

WHEREAS, the Director of the Department of Public Works and Interim Chief Procurement Officer recommend that the City Commission approve and authorize the issuance of a Purchase Order to Glade & Grove for New Holland Agricultural Tractor model TS6.120 HC w/Beach Tires in an amount up to \$122,680.86; and

WHEREAS, funding for the Purchase Order has been appropriated and exists in account number(s) 557.519901.51900.564520.001762.000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it approves and authorizes the issuance, by the appropriate City officials, of a Purchase Order to Glade & Grove together with such non-material changes as may subsequently be agreed to by the City Manager and approved as to form by the City Attorney.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
