A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE A PROFESSIONAL SERVICES AGREEMENT WITH RMGA, INC., D/B/A RICHARD MANDELL GOLF ARCHITECTURE, FOR GOLF COURSE ARCHITECTURE CONSULTING SERVICES FOR THE HOLLYWOOD BEACH GOLF COURSE AND CLUBHOUSE PROJECT, A GENERAL OBLIGATION BOND PROJECT, IN AN AMOUNT NOT TO EXCEED \$356,205.00.

WHEREAS, the Hollywood Beach Golf Course and Clubhouse project is part of the General Obligation Bond Project list approved by the voters in March 2019; and

WHEREAS, on January 20, 2021, the City Commission passed and adopted Resolution No. R-2021-022, ranking golf course architecture consultants selected under Request for Qualification RFQ-4652-20-DCM, and authorizing the appropriate City officials to negotiate an agreement with the highest-ranked firm, RMGA, Inc., d/b/a Richard Mandell Golf Architecture, to be considered by the City Commission at a later date; and

WHEREAS, the Department of Design and Construction Management has negotiated a project scope and fee with RMGA, Inc. for an amount not to exceed \$356,205.00 that staff has determined to be fair and reasonable and in accordance with industry standards; and

WHEREAS, the Director of DCM recommends that the City Commission approve and authorize the appropriate City officials to execute the attached Professional Services Agreement with RMGA, Inc., d/b/a Richard Mandell Golf Architecture, based upon the proposal set forth in the attached Exhibit "A" that will be included in the agreement; and

WHEREAS, funding for this project was included in the amended FY2021 Capital Improvement Plan and is available in account number 333.309901.57200.563010.001194.000.000.
