We have reviewed the bid proposal documents opened on April 3, 2024 for the subject project. Our review did not include a determination of bidder responsiveness; however, all requested proposal items were submitted, with the exception of the Trench Safety Form.

Based on our experience administering construction by this contractor on other projects, we consider this contractor responsible and qualified to perform the work described in the contract documents. As such, we recommend that the Southern Regional Wastewater Treatment Plant Treatment Unit Grit Removal contract be awarded to Cardinal Contractors, Inc.
