The firm of Craven Thompson & Associates, Inc. (CTA) is pleased to provide the following proposal for Civil Engineering and Geotechnical Testing Services per our professional Services Agreement for Civil / Landscape Architecture / Planning Engineering Services, No. DS 18-014. This proposal is for the preparation of storm water improvements at the City of Hollywood Rotary Park fields. The provided services include survey, design, permitting, bidding assistance and construction administration to complete the project. Based upon correspondence with City staff and various site meetings, it is our understanding the City would like to improve the drainage issues in portions of the ballfields, specifically the four fields adjacent to the canal on the east side of the park (Pell, Whitlock, Hartman & Shull). Additionally, City staff indicated the need to design improvements to the Drainage System in the Alley along the West property line in order to eliminate or reduce ponding/flooding as much as possible, which may be completed at the City's request with a separate proposal.

CTA has completed the initial project scope, which included geotechnical testing and preparation of a Stormwater Improvement Report under separate proposal. The Improvements report included preparation of conceptual designs & the estimated associated costs for different drainage improvement options in the areas experiencing excessive flooding. The City recently met with CTA to review the report and directed CTA to prepare permit and construction documents to implement the Phase I Improvements (with slight modifications) and Option 2 - Ballfield Underdrains. This will become the basis of the final design along with the notes from the Site Meeting for the preparation of the Bid Package and Construction Documents. The Alley improvements are not included in this proposal and will be completed under a separate design proposal and project at the City's discretion.

# I. SURVEYING SERVICES

### 1.1 <u>Topographic Survey</u> (CTA Task No. 11050)

Prepare a topographic survey of the property located at 3102 Taft Street, Hollywood, Florida.

The survey will meet the current surveying requirements under the "Standards of Practice" for the Board of Professional Surveyors and Mappers of the State of Florida, as defined in Chapter 5J-17, Florida Administrative Code.

The Project is further defined as follows:

- The topographic survey will include recovery of property boundary monumentation in the vicinity of the subject property, in order to determine its geographic relationship to boundary lines, under tax folio #5142 08 00 0022.
- Locations of all <u>aboveground and visible improvements</u>, including all pavement, slabs, buildings, fences, signs, overhead wires, utility features, within the limits of this survey and immediately adjacent to the site.
- Cross-section elevations will be obtained at 50-foot intervals along the adjacent alley on the West side of the park, locations will be obtained from fence to fence and expanded at entrances to the park.
- Obtain drainage structure as-built information on the structures located on the
  perimeter roadway at Taft Street and Arthur Street and within the survey limits,
  including rim and invert elevations, with pipe size and type of material for structures
  that are accessible and clear of debris. Inaccessible structures will be noted on the
  survey.
- Obtain horizontal and vertical locations of five (5) pot holes and plot the locations in the survey file.
- Elevations within the site will cover pavement, curbing, high & low points, sidewalks, building finish floors, and natural ground spots for design purposes.
- All elevations will be relative to North American Vertical Datum of 1988 (NAVD88) and based on National Geodetic Survey (NGS), Florida Department of Transportation (FDOT), or South Florida Water Management benchmarks.
- Benchmarks will be provided on semi-permanent survey control points, set on, or immediately adjacent to the project, and shown on the survey with X, Y, Z values for future construction.
- Trees will be located, numbered and defined by common name to the best of our ability with diameter at breast height, and canopy with.
- Only easements shown on recorded Plats will be shown on survey, no title search will be performed.
- The survey will be in the projection: State Plane, Florida East Zone, NAD 83(90), US Survey feet.
- The preparation of the survey drawing will be in Autodesk Civil 3D, Version 2019 or higher, drawing file format.
