Thank you for your interest in Xylem Dewatering Solutions Inc, and our Godwin Pumps of America line of Critically Silenced Trailer Mounted pumps.

Based on our discussion during my last meeting at your facility last Tuesday 6-18-2024 we have prepared the following quote for our Godwin Pumps of America model CD225M (3) with standard JCB TCAE-93 (FT4) EPA emissions compliant diesel engine, and model CD300M (1) with standard John Deere 6068HC09 (FT4) EPA emissions compliant diesel engine.

We can offer the CD225M also with a John Deere engine with an adder.

The 8" CD225M pump offers flow rates to 1900 USGPM @ 80' TDH and has the capability of handling solids up to 3.0" in diameter. The 12" CD300M pump offers flow rates to 4000 USGPM @ 90' TDH and has the capability of handling solids up to 3.7" in diameter. Both models are offered with Critically Silenced noise isolation and trailer.

Indefinite dry running is no problem due to the unique Godwin liquid bath mechanical seal design. Solids handling, dry-running, and portability make these Godwin Pumps the perfect choice for dewatering and bypass applications.

The Critically Silenced unit is engineered from start to finish for quiet operation. The enclosure consists of 14 gauge sheet metal lined with 1" and 2" layers of polydamp acoustical sound deadening material. The engine is designed with a critical grade silenced muffler, silenced the priming exhaust, and isolated engine vibration to further reduce operating noise. Hinged, lockable doors provide convenient access to operating controls and service locations. Sound levels are approximately 69 dBA at 30 feet.

All pricing is based on the Florida Sheriff's Contract #FSA23-EQU21.0, Item #313. There are no delivery freight charges when utilizing the FSA Contract.


