Explanation:

The purpose of the attached Resolution is to initiate regulations for rooftop photovoltaic solar systems as a part of the Broward County ("County") Go SOLAR program.

The Go SOLAR online permitting system allows for users to register, submit, pay for, and obtain their permits online. There is a reduced fee associated with the program and plans are reviewed both by the City of Hollywood and Broward County.

The County will be granted the authority to receive web-based applications for rooftop PV installations on behalf of the City. Each applicant will submit \$552.00 via credit card

payment. The City will receive \$539.00 for each permit and the County will retain a \$13.00 credit card convenience fee.

The applicant's payment is broken down as follows:

Basic permit fee	\$500.00
Board of Rules and Appeals Surcharge	\$24.00
Section 553.721, Florida States Surcharge	\$7.50
Section 463.631, Florida States Surcharge	\$7.50
Credit Card Convenience Fee (County portion)	<u>\$13.00</u>
TOTAL FEE	\$552.00

The City retains the right to conduct inspections and re-inspections of rooftop PV installations which were permitted under the Go SOLAR permitting process. Re-inspection applications will be scheduled through the web based permitting system, and applicants will submit \$52.00 via credit card payment. The City will receive \$50.00 for each re-inspection and the County will retain a \$2.00 credit card convenience fee.

The Agreement may be terminated by either party with 90 days written notice.
