A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, DESIGNATING THE CONTIGUOUS PROPERTIES LOCATED AT 1600 SOUTH PARK ROAD, HOLLYWOOD, FLORIDA 33021 (PARCEL ID 514220000040, 514220000140, 514220000150, NOS. 514220000170, AND 514220000010) AS A BROWNFIELD AREA FOR THE PURPOSE OF ENVIRONMENTAL REMEDIATION, REHABILITATION, AND ECONOMIC DEVELOPMENT: AUTHORIZING AND DIRECTING STAFF TO NOTIFY THE FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION OF THE DESIGNATION: AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the State of Florida has provided in the Brownfields Redevelopment Act (the "Act"), cited as Florida Statutes Sections 376.77 – 376.85, for the designation, by resolution of a municipal governing body, of one or more parcels as a "brownfield area," and for the corresponding provision of environmental remediation, rehabilitation and economic development; and

WHEREAS, the City Commission of the City of Hollywood, Florida has proposed the designation of the property located at 1600 South Park Road, Hollywood, Florida, identified in Exhibit "A", attached hereto and incorporated herein by reference ("the HIAD"); and

WHEREAS, the City Commission has reviewed the requirements for brownfield area designation, as specified in Florida Statutes Sections 376.80(2)(a) and 376.80(2)(b), and has determined that the HIAD qualifies for designation as a brownfield area because the following requirements of the Florida Statute Sections 376.80(2)(a) and 376.80(2)(b) have been met:

- 1. The HIAD warrants economic development and has a reasonable potential for such activities.
- 2. The HIAD represents a reasonably focused approach and is not overly large in geographic area.
- 3. The HIAD has potential to interest the private sector in participating in rehabilitation.
- 4. The rehabilitation and redevelopment of the HIAD will result in a positive economic impact comprised of redevelopment projects and job creation.
- 5. The redevelopment of the HIAD is consistent with the City's Comprehensive Plan and land development regulations.

6. The City has complied with the procedures outlined in the Act and has provided notice as required by law, Florida Statutes, Section 166.041(3)(c)(2);

; and

WHEREAS, the City will notify the Florida Department of Environmental Protection of this Brownfield Area designation to facilitate environmental remediation, rehabilitation and economic development of such area consistent with the Act; and

WHEREAS, the procedures set forth in subsections 376.80(1) and 376.80(2)(a), Florida Statutes, have been followed, and proper notice has been provided in accord with Section 376.80 and Subsection 125.66(4)(b)(2), Florida Statutes.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the area located at 1600 South Park Road, Hollywood, Florida which is depicted on Exhibit "A," and attached hereto and incorporated herein by reference, is hereby designated a Brownfield Area for environmental remediation, rehabilitation and economic development purposes per the Act.

<u>Section 2</u>: That the legal description of the property designated as a Brownfield Area is as follows:

<u>Section 5:</u> That this resolution shall be in force and effect immediately upon its passage and adoption.






## CITY OF HOLLYWOOD PUBLIC HEARING NOTICE OF BROWNFIELD AREA DESIGNATION
