With reference to our recent telephone conversation and subsequent emails please find the cost brake down of each task as follow:

1. Verification of defects in the month of February 2017
 - 1.1 Site visits
 - Project Engineer - 16 hrs x \$125 = \$2,000
 - Engineer - 16 hrs x \$105 = \$1,680
 - 1.2 Analysis Draft
 - Engineer - 16 hrs x \$105 = \$1,680
 - Project Engineer 8 hrs x \$125 = \$1,000

Our fee for said services would be \$6,360.

2. Cost of repair recovery from the developer/design and construction team prior to litigation.
