A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE THE ATTACHED CONTRACT, BETWEEN VISUALSCAPE, INC. AND THE CITY OF HOLLYWOOD, FOR MEDIAN LANDSCAPE REPLACEMENT ALONG A1A, IN THE AMOUNT OF \$65,000.00 AND TO AMEND THE APPROVED FISCAL YEAR 2017 CAPITAL IMPROVEMENT PROGRAM, AS SET FORTH IN EXHIBIT A.

WHEREAS, the Department of Public Works and the Beach Community Redevelopment Agency have determined that the landscape in medians along A1A between Bougainvillea Terrace and Harrison Street need to be replaced; and

WHEREAS, specifications and details to replace the trees and landscape material were prepared by City staff and the Notice to Bidders was advertised online via BidSync on December 11, 2016; and

WHEREAS, these construction documents and specifications were viewed by forty-three (43) vendors on BidSync and twelve (12) vendors downloaded the Project Manual and specifications; and

WHEREAS, through receipt of the City's bid specifications for this project, all contractors have been provided with a copy of the City's contract, including the terms and conditions contained therein; and

WHEREAS, five (5) bids were received and publicly opened at 10:00 AM on January 11, 2016, with (1) bid being rejected as not complete and excluding base bid items, and the responsive bids are as follows:

VisualScape, Inc. Miami, FL	\$65,000.00	
Landscape Service Professionals, Inc. Tamarac, FL	\$99,000.00	
Bannerman Landscaping Inc. Opa Locka, FL	\$100,000.00	
Arazoza Brothers Corp. Homestead, FL	\$114,446.36	; and

WHEREAS, City staff reviewed the four (4) bids and determined that the bid submitted by VisualScape, Inc. was the overall lowest, responsive and responsible bid, and have recommended the award of the bid to VisualScape, Inc. in the amount not to exceed \$65,000.00; and

WHEREAS, it is necessary to amend the approved FY 2017 Capital Improvement Program and allocate funding in the amount of \$23,000.00 for median landscape replacement as set forth in Exhibit A, attached; and

WHEREAS, the City is being partially reimbursed by the CRA in an amount not to exceed \$43,996.00 for landscape upgrades and enhancements from account number 63.0100.22059.554.005224 and sufficient funding has been provided in the FY 2017 Operating Budget for the Beach Community Redevelopment Agency for said use;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That it hereby approves and authorizes the execution, by the appropriate City Officials, of the attached contract, between VisualScape, Inc., and the City of Hollywood, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legality by the City Attorney.

Section 2: That it hereby approves the amendment to the approved FY 2017 Capital Improvement Program, as set forth in the attached Exhibit A.

Section 3: That this resolution shall be in full force and effect immediately upon its passage and adoption.
