A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE A BLANKET PURCHASE AGREEMENT WITH ALL PAVING, INC. FOR PAVING CONSTRUCTION SERVICES OF PARKING LOTS AND PARK ROADS AT DOWDY SPORTS FIELD, A GENERAL OBLIGATION BOND PROJECT, IN AN AMOUNT NOT TO EXCEED \$46,110.00, BASED ON PALM BEACH COUNTY'S BID FOR PROJECT NO. 2020055 IN ACCORDANCE WITH SECTION 38.41(C)(5) OF THE PROCUREMENT CODE ("PIGGYBACK").

WHEREAS, the Dowdy Sports Field project is part of the General Obligation Bond Project list approved by voters in March 2019, and includes resurfacing parking lots; and

WHEREAS, the Department of Design and Construction Management ("DCM") determined that it is necessary to retain a contractor for paving services that includes the asphalt milling, paving, and pavement markings of two north parking lots within Dowdy Sports Field; and

WHEREAS, on June 11, 2020, the desired services were competitively bid by Palm Beach County for Project No. 202055, with a contract term of three years from November 17, 2020, the date of execution, with an option to extend the contract upon mutual agreement of the parties; and

WHEREAS, Palm Beach County awarded the bid to All Paving, Inc. ("All Paving") and All Paving has agreed to extend to the City the same pricing and terms and conditions as set forth in the Palm Beach County bid in an amount not to exceed \$46,110.00; and

WHEREAS, the City is currently utilizing All Paving for various projects, and the cumulative amount being paid to the company has exceeded \$100,000.00 for Fiscal Year 2022; and

WHEREAS, City Commission approval is required for the payment of additional fees to All Paving pursuant to Section 38.38 of the Procurement Code; and

WHEREAS, Section 38.41(C)(5) of the Code of Ordinances allows the Chief Procurement Officer to procure, without following formal solicitation procedures, all goods, supplies, materials, equipment, and services that are the subject of contracts with the state, its political subdivisions, the United States government, other governmental entities, or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof ("piggyback"), provided that the goods, supplies,

materials, equipment, or services are the subject of a price schedule negotiated by the entities listed above and is based strictly on competitive bids, quotations, or competitive proposals and not on any preference; and

WHEREAS, utilization of other governmental entities' contracts shall be permitted only during the term of the other governmental entity's contract; and

WHEREAS, the Director of DCM and the Chief Procurement Officer recommend that the City Commission approve the execution of the attached Blanket Purchase Agreement with All Paving based on Palm Beach County's bid for Project No. 202055 to provide paving construction services at Dowdy Sports Field; and

WHEREAS, funding for this project was included in the amended the FY 2022 Capital Improvement Plan, and is available in account number 333.309901.57200.563010.001197.000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the execution, by the appropriate City officials, of the attached Blanket Purchase Agreement with All Paving, Inc., together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
