A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF APPROVING HOLLYWOOD, FLORIDA, AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE AN AUTHORIZATION TO PROCEED FOR ADDITIONAL SERVICES FOR ENGINEERING DESIGN AND PERMITTING WITH BERMELLO AJAMIL AND PARTNERS. INC. FOR THE AVANT GARDE ACADEMY SAFE ROUTE TO SCHOOLS PROJECT, A FLORIDA DEPARTMENT OF TRANSPORTATION LOCAL AGENCY **PROGRAM** PROJECT, IN AN AMOUNT UP TO \$18,600.00, FOR A TOTAL CONTRACT AMOUNT OF \$136,980.00.

WHEREAS, on March 1, 2022, a Local Agency Program ("LAP") Agreement, Contract No. G2675, was entered into with the Florida Department of Transportation ("FDOT"), authorizing construction reimbursement funds in the amount of \$945,042.00 for the construction of the Avant Garde Academy Safe Routes to School Project; and

WHEREAS, the LAP Agreement requires that the recipients of federal funds submit design documents at several milestones and demonstrate compliance with federal requirements; and

WHEREAD, the Department of Design and Construction Management ("DCM") recommended the hiring of Bermello Ajamil and Partners, Inc. ("Bermello") to provide surveying, engineering design, permitting and construction phase engineering services for this project; and

WHEREAS, Bermello and the City currently have a Continuing Services Agreement for engineering services that was approved by the City Commission pursuant to Resolution No. R-2018-400 on December 19, 2018; and

WHEREAS, on August 31, 2022, the City Commission passed and adopted Resolution No. R-2020-133, approving the award and issuance of an Authorization to Proceed with Bermello in an amount up to \$108,280.00; and

WHEREAS, on April 19, 2023, Authorization to Proceed No. 3 was issued for additional design services related to the North 25th Ave redesign, Arthur Street to Johnson Street, in the amount of \$10,100.00, under the City Manager's authority, and

WHEREAS, as required by field conditions and conflicts not likely to be resolved in a timely manner, additional efforts and time were spent on field inspections, survey, design and permitting by Bermello as requested by City staff during construction; and

WHEREAS, this resulted in additional services being negotiated in the amount of \$18,600.00, and staff has determined that the scope and fee is fair and reasonable and in

accordance with industry standards; and

WHEREAS, the City utilizes Bermello for other services, and the amount being paid to Bermello is expected to exceed \$100,000.00 for Fiscal Year 2023 and, therefore, City Commission approval is required for the payment of fees for these services pursuant to Section 38.38 of the Procurement Code; and

WHEREAS, the Director of DCM recommends that the City Commission authorize the appropriate City officials to issue an Authorization to Proceed with Bermello Ajamil and Partners, Inc. for additional services in the amount of \$18,600.00, for a total contract amount of \$136,980.00; and

WHEREAS, funding for this project was included in the amended FY 2023 Capital Improvement Plan, and is available in account number 117.179901.54100.563010.001121.000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it approves and authorizes the execution, by appropriate City officials, of the attached Authorization to Proceed No. 4 with Bermello Ajamil and Partners, Inc., together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form by the City Attorney.

<u>Section 3</u>: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
