WHEREAS, certain routine and periodic budgetary adjustments and transfers are appropriate; and

WHEREAS, since the adoption and subsequent amendment of the Fiscal Year 2024 budget for the Downtown District, it is necessary to amend the annual budgeted expenditures as more specifically described in the attached Exhibits "A" and "B".

NOW, THEREFORE, BE IT RESOLVED BY THE HOLLYWOOD, FLORIDA COMMUNITY REDEVELOPMENT AGENCY:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it approves and adopts the attached Fiscal Year 2024 Amended Budget as more specifically set forth in Exhibits "A" and "B" for the Downtown District of the CRA.

<u>Section 3</u>: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
