On behalf of the owner and applicant, BLUEVIS LLC ("Applicant"), I am writing to report that a virtual community meeting was held on May 15, 2025, from 2:27 p.m. to 3:02 p.m., to present and discuss the proposed development of the Padel Club project located at 600 Knights Road, Hollywood, FL 33021.

The meeting was attended by members of the project team, including Corey Seltenright, Tony Leon, John Wyatt, Stanley Fardin, Ismael Fernandez, and Maria Pena. Despite proper notice being issued, no members of the public or representatives from the City Planning Department were present. After allowing a 15-minute waiting period for additional participants, the meeting proceeded as scheduled.

During the meeting, the development proposal was presented, including the legal description, project scope, and architectural layout. The proposed Padel Club involves the renovation of the existing building to serve as the main clubhouse, which will support the construction of nine outdoor padel courts. The clubhouse will include a coffee shop, retail store, recreational lounges, and restroom and shower facilities, offering a comprehensive space for sports, leisure, and community activity. The building will encompass 7,236 square feet, while the full site area spans approximately 86,967.7 square feet, designed to accommodate courts, landscaping, parking, and additional amenities. Renderings and site plans were reviewed during the presentation, and the project was described as being classified under A1 – Assembly – Recreation, reflecting its intended use as a community-oriented recreational facility. No questions or comments were received from attendees.




