



#### **City of Southfield** (Pollution Control Facilities Contracts 10A & B & 11

The above project ended its arbitration in November, 2007.

Giannetti Contracting Corporation (Plaintiff) is seeking damages for delays & additional work performed under two separate contracts.

**AT & T V. Giannetti** AT & T is seeking damages from Giannetti for damages to underground cables. Giannetti is disputing the claim.

This claim went to Arbitration in November 2008 and is pending a decision.

**Volunteers of America V. Giannetti** VOA had a dispute with a subcontractor working under Giannetti, the case has been dismissed.

**Irene Perez V Giannetti.** Irene Perez sued Giannetti for an automobile accident claim. This case has been settled by the insurance company.

**Olympic Corp V Giannetti & others. Mechanical Lien foreclosure.** Giannetti and other subcontractors were not paid for work completed. This case has been settled.
