A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE A SERIES OF CONSULTANT'S AUTHORIZATIONS TO PROCEED (ATPS) BETWEEN SYNALOVSKI ROMANIK SAYE, LLC AND THE CITY OF HOLLYWOOD TO PROVIDE PROFESSIONAL ARCHITECTURAL AND ENGINEERING SERVICES FOR THE DESIGN OF A NEW TEMPORARY BEACH MAINTENANCE COMPOUND ON AN FDOT PARKING LOT UNDER THE HOLLYWOOD BOULEVARD BRIDGE IN AN AMOUNT NOT TO EXCEED \$66,000.00.

WHEREAS, in the summer of 2012, Beach Maintenance staff lost their facility at the Johnson Street Garage and have been temporarily relocated to an old Fire Station on A1A; and

WHEREAS, two (2) temporary locations have been identified to once again relocate Beach Maintenance staff; and

WHEREAS, one (1) of these locations is to an existing FDOT parking lot under the Hollywood Boulevard Bridge; and

WHEREAS, because the City has multiple buildings and other facilities which it needs to maintain on a regular basis, and the expertise of professional architectural firms is sometimes required and the Department of Public Works solicited a Request for Qualifications (RFQ) to create a pool of architectural firms; and

WHEREAS, on February 18, 2015, through Resolution R-2015-042, the City Commission authorized the negotiation and execution of contracts with the three highest ranked firms, one of which was Synalovski Romanik Saye, LLC; and

WHEREAS, Synalovski Romanik Saye, LLC was asked to provide architectural and engineering design services related to designing a new temporary Beach Maintenance compound on an FDOT parking lot under the Hollywood Boulevard Bridge; and

WHEREAS, the total estimated design fees for the new temporary Beach Maintenance compound are \$66,000.00 and the fees will be paid through a series of ATPs as each portion of the project progresses; and

WHEREAS, the Director of Public Works recommends that the City Commission authorize the appropriate City Officials to execute a series of the attached Consultant's

Authorizations to Proceed between Synalovski Romanik Saye, LLC and the City of Hollywood, together with such nonmaterial changes as may be subsequently agreed to by the City Manager and approved as to form and legality by the City Attorney, in an estimated lump sum amount of \$12,600.00; and

WHEREAS, all design services for the new temporary Beach Maintenance compound located under the Hollywood Boulevard Bridge are budgeted in account number 34.5100.15514.519.006301;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1:</u> That it hereby approves and authorizes the execution, by the appropriate City officials, of a series of Consultant's Authorizations to Proceed (ATPS) between Synalovski Romanik Saye, LLC and the City of Hollywood, in an amount not to exceed \$66,000.00, together with such nonmaterial changes as may be subsequently agreed to by the City Manager and approved as to form and legality by the City Attorney.

<u>Section 2:</u> That this resolution shall be in full force and effect immediately upon its passage and adoption.
