A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE THE ATTACHED AGREEMENT BETWEEN THE SHERIFF of BROWARD COUNTY, FLORIDA (“BSO”) AND THE CITY OF HOLLYWOOD FOR THE TEMPORARY USE OF FIRE RESCUE AND EMERGENCY SERVICES EQUIPMENT AND/OR VEHICLES.

WHEREAS, the City’s Fire Rescue and Beach Safety Department’s (“Department”) is in the process of repairing its emergency service vehicles; and

WHEREAS, during the repair timeframe, it is desirable to assure optimal service coverage whereby the Department desires to obtain a Fire Engine from the Sheriff of Broward County’s Department of Fire Rescue and Emergency Services (“BSO”); and

WHEREAS, BSO has agreed to allow the Department to temporarily use Fire Recue and Emergency Services Equipment and/or Vehicles as needed by the City; and

WHEREAS, the parties desire to execute the attached Agreement for the utilization of BSO’s equipment and/or vehicles; and

WHEREAS, the attached Agreement requires the City to assume liability and to the extent permitted by law indemnify BSO as well as self-insure its respective interests in the equipment and/or vehicles; and

WHEREAS, the City Commission of the City of Hollywood deems it in the best interests of the residents of the City to enter into the Agreement, a copy of which is attached as Exhibit “A”;

NOW, THEREFORE BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That it hereby approves and authorizes the execution, by the appropriate City Officials, of the attached agreement between Broward County Sheriff, Division of Fire Rescue and the City of Hollywood, together with such non-material changes as may be acceptable to the City Manager and approved as to form and legality by the City Attorney.
