A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE BLANKET PURCHASE ORDERS TO GPE ENGINEERING & GENERAL CONTRACTOR AND SOUTHEASTERN ENGINEERING CONTRACTORS, INC. FOR STORMWATER CONSTRUCTION, FOR A ONE YEAR TERM IN A TOTAL AGGREGATE AMOUNT NOT TO EXCEED \$1,000,000.00 BASED UPON THE CITY OF FORT LAUDERDALE'S BID NUMBER 473-11907 IN ACCORDANCE WITH SECTION 38.40(C)(5) OF THE PURCHASING ORDINANCE (PIGGYBACK); APPROVING AN AMENDMENT TO THE FISCAL YEAR 2020 CAPITAL IMPROVEMENT PROGRAM.

WHEREAS, the City owns, operates and maintains stormwater facilities, including 10 stormwater pump stations, 75 major outfalls, 45 weir control structures, 69,000 linear feet trench drains and 128 miles of pipes and culverts; and

WHEREAS, these stormwater facilities require miscellaneous rehabilitation, repair and replacement work on an as-needed basis; and

WHEREAS, similar construction services were competitively bid by the City of Fort Lauderdale pursuant to its Bid Number 473-11907 – Stormwater Work on April 20, 2017; and

WHEREAS, the City of Fort Lauderdale awarded Bid Number 473-11907 – Stormwater Work to GPE Engineering & General Contractor (“GPE”), Southeastern Engineering Contractors, Inc. (“SEC”), Hinterland Group Inc., and DP Development of the Treasure Coast, LLC, and the contract is valid from September 24, 2017 through October 24, 2021; and

WHEREAS, GPE and SEC have demonstrated their experience and quality of work through many projects completed for the City, and both have agreed to extend to the City the same pricing as outlined in City of Fort Lauderdale’s Bid Number 473-11907; and

WHEREAS, the total project cost is an amount not to exceed \$1,000,000.00, and the project cost will be divided between GPE and SEC as follows: (1) GPE – in an amount not to exceed \$500,000.00; and (2) SEC – in an amount not to exceed \$500,000.00; and

WHEREAS, Section 38.40 (C)(5) of the Purchasing Ordinance allows the Director to procure, without following formal procedures, all goods and services which are the subject of contracts with the state, its political subdivisions, the United States government, other governmental entities, or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof, provided that the goods and services are: (i) the subject of a price schedule negotiated by the state or the United States government, or (ii) the subject of a contract with another governmental entity or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof, which contract is based strictly on competitive bids or competitive proposals and not on any preference; and

WHEREAS, it is necessary to amend the approved FY 2020 Capital Improvements Program as set forth in the attached Exhibit "A"; and

WHEREAS, the project shall be for a one-year term and may be renewed for additional one-year periods upon expiration of the initial term, not to exceed a maximum of four additional renewal periods; and

WHEREAS, the Director of Public Utilities and the Director of Procurement and Contract Compliance recommend that the City Commission approve the issuance of blanket purchase orders to GPE and SEC for the Stormwater Construction.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the issuance, by the appropriate City officials, of a blanket purchase order to GPE Engineering & General Contractor, embodying the terms and conditions approved by the City Commission this date in a form acceptable to the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 3: That it approves and authorizes the issuance, by the appropriate City officials, of a blanket purchase order to Southeastern Engineering Contractors, Inc. embodying the terms and conditions approved by the City Commission this date in a form acceptable to the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 4: That it approves and authorizes an amendment to the approved FY 2020 Capital Improvement Program, as more specifically set forth in the attached Exhibit "A".
