A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE EXECUTION OF AN INTERLOCAL AGREEMENT WITH BROWARD COUNTY FOR THE DEVELOPMENT OF THE CITY OF HOLLYWOOD PUBLIC ART MASTER PLAN, IN AN AMOUNT NOT TO EXCEED \$49,999.00; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Hollywood ("City") has identified the need to develop a comprehensive Public Art Master Plan to guide future investments in public art, placemaking, and design integration across the City's public realm, including streetscapes, parks, civic buildings, and corridors; and

WHEREAS, Broward County ("County"), through its Cultural Division, has knowledge and experience administering municipal public art programs and providing public art planning and consulting services, including the development of public art master plans for municipalities within the region; and

WHEREAS, the City desires to enter into an Interlocal Agreement with County pursuant to Section 163.01, Florida Statutes, for County to provide consulting services toward the creation and delivery of the City's Public Art and Design Master Plan as set forth in the attached Agreement and Exhibit A (Scope of Services); and

WHEREAS, the Interlocal Agreement provides for compensation to County in a not-to-exceed amount of \$49,999.00 (Phase 1: \$35,000.00; Phase 2: \$14,999.00); and

WHEREAS, funding for the interlocal agreement is available in FY 2026 Operating Budget in account number 001.140401.51500.631170.000000.000.000; and

WHEREAS, the Interlocal Agreement includes indemnification obligations requiring the City to indemnify, hold harmless, and defend County to the greatest extent permitted under Florida law; and

WHEREAS, the City Commission finds that approval of the Interlocal Agreement and authorization for the appropriate City official(s) to execute the Agreement is in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes execution of the attached Interlocal Agreement between Broward County and the City of Hollywood for the Broward County administered Public Art Program and the development of the City of Hollywood Public Art and Design Master Plan, in a not-to-exceed amount of \$49,999.00.

Section 3: That the City Manager is authorized and directed to execute the Interlocal Agreement on behalf of the City and to execute any other agreements, amendments, or documents reasonably necessary to effectuate the purpose of the Agreement, and approved as to form and legal sufficiency by the City Attorney.

Section 4: That, to the extent required, the City Commission hereby declares by the required vote that use of the Best Interest exception to competitive solicitations is appropriate for this Agreement based on the factual findings presented to the City Commission.

Section 5: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
