Due to a software migration issue with Axon, they were unable to provide the detailed quote identifying the pay off of the equipment in 3 years as opposed to 5, however the estimated cost remains the same, separate of financing options. Hollywood Police Department Body-Worn Camera Project

Statement of the Problem

The City of Hollywood Police Department (HPD) is an accredited law enforcement agency that is responsible for public safety in the City of Hollywood. Hollywood is a principal city in the Broward County Metropolitan Area, with a resident population of approximately 155,000. Hollywood is densely populated over 30 square miles, with over 17 miles of waterway and beaches. Hollywood is the 3rd largest municipality in Broward County, which is the 17th most populous counties in the United States. Hollywood is home to the South Satellite Regional Courthouse, has 7 miles of beachfront Condominiums and hotels, retains 80% of Port Everglades, the Ft. Lauderdale/ Hollywood International Airport, and surrounds the Hollywood Seminole Indian Reservation which is home to the Hard Rock casino and hotel.

It is the HPDs vision to mirror nationwide best practices and Department of Justice recommendations. In line with *The Six Pillars of the President's Task Force* report issued in 2015, the HPD continues to provide a high level of service its citizens and guests. *Pillar One* "emphasizes the importance the faith of the community in its law enforcement officers". BWCs provide audio, video and photographic evidence during officer interactions with the public. BWC audio and video footage can provide insight into situations that may in the absence of such recordings could be interpreted in many ways.

The HPD Internal Affairs unit is responsible for investigating complaints from the public, as well as internal policy adherence.

Internal Affairs Complaints and Use of Force 2018-2020

The addition of BWCs would affect the number of un-sustained complaints by potentially providing evidence for the stated interaction. Dr. Michael White of the Bureau of Justice Assistance Body Worn Camera Expert Panel determined there is a notable "civilizing effect" that the presence of BWCs have on police/citizen encounters. Thus use of force complaints may also be reduced by the mere presence of an officer possessing and activating a BWC. HPD recognizes that BWCs will increase the public perception of transparency and faith that officers are performing their duties at the highest level of professionalism and will hold officers accountable for their actions. Also supporting *Pillar One,* the HPD releases an annual report that is published on the City of Hollywood website (Hollywoodfl.org). This report indicates crime data and demographic information. According to the 2020 US Census Report, the City of Hollywood has a resident population that is 68% white, 18% Black or African American, and approximately 65 all other races. The City population although predominantly white, experiences a diverse tourist and commuter population of multiple ethnicities that frequent the city for festivals, parades, and other recreational activities. Maintaining the trust of all races and ethnicities is a priority for HPD,

and the deployment of BWCs would support both the Department of Justice's recommendations and the City of Hollywood's goals.

Project Design and Implementation

Pilot Program: In January 2020 the HPD implemented a pilot program to test and evaluate Body-Worn Cameras for its sworn officers. The program consisted of 11 Officers, 2 Sergeants, 1 Lieutenant and a civilian Supervisor. All the participants were volunteers that were tasked with the unbiased evaluation of the camera technology. The cameras were deployed to the officers for 30 days. The officers were assigned amongst multiple shifts and uniform units. A General Order was adopted to govern the use and records management of any footage recorded. Officers were expected to abide by the directives in the order and utilize the cameras in their daily duties. After 2 months of test and evaluation, the COVID-19 emergency terminated the ability to continue with the pilot program.

The Axon Enterprise Body 3 camera has been selected as the camera of choice for the full program implementation. The officer's positive feedback regarding the user-friendliness of the camera and software, the pricing of the companies' service were large factors in our decision. The Broward County State Attorney's Office digital evidence unit also highly recommended Axon Enterprises product due to their interoperability with their current software and hardware. The Broward County State Attorney's Office fully supports HPD implementing a BWC program and has issued a letter of support (see attached file). The HPD is one of the few agencies that has been unable to fund a BWC deployment for its officers.

HOLLYWOOD POLICE DEPARTMENT BODY-WORN CAMERA PROJECT

The BWC pilot program has allowed HPD to identify infrastructure and associated costs with a full program implementation. The funds of this Grant will support the purchase of 325 Axon Body 3 Cameras, which will be deployed to all uniformed officers. The funding will further support the licensing required to access the cloud storage of Evidence.com, a leader in secure digital storage.

Program Goals are as follows:

- Capture statements, officer and public interactions and provide evidentiary footage 8
- Heighten the officers ability to accurately document an incident for reporting purposes or courtroom testimony
- Improve citizen interactions with officers
- Provide insight for the officer and supervisor for self-critique, enhance professionalism, and identify training deficiencies.
- Reduce the number of complaints against officers
- Reduce the amount of time spent on investigating complaints against officers

The full implementation of the BWC program with be a 3 phased process. Prior to the implementation of the first phase, it is the HPDs goal to hire 3 Digital Evidence Specialists and add an additional Sergeants position to the current staffing provisions. The Sergeant will work in conjunction with the Facilities and Property Manager to develop training protocols, establish the BWC Digital Evidence Specialist policy and oversee the rollout of the entire program. The Facilities and Property Manager has already identified a location within police headquarters that will house the multi-bay charging and data transfer docks for the Axon Body 3. The department is currently funding the retrofit of high-speed fiber optic data lines to the BWC room, to allow for

higher volume of uploads from the officer's BWC to Evidence.com storage cloud. The city of Hollywood Commissioners have committed to supporting the BWC program with funding (to be written in FY22 Budget) and support from the Information Technology department.

The largest stakeholder to benefit from this program is the community at large. With evidentiary footage collection and dissemination, the HPD will increase its transparency within the public, and enhance agency accountability amongst its officers. The demand for HPD to implement this program is high, and HPD intends to meet and exceed the demands of its community and City Officials. The Public Information Officer will be formulate a press release once the BWC program has launched and is in service. The HPD also maintains multiple social media platforms which will also be utilized to increase awareness of the BWC deployment, as will information be posted on the agency website (hollywoodpd.org).

Countless agencies around the region and nation have already implemented BWC programs and have evaluated their mistakes and made adjustments where necessary. During the pilot program, the Supervisor overseeing the program also attended a county wide consortium for BWCs. The collaboration of surrounding jurisdictions meet routinely to discuss interoperability issues, technical findings, and increase the overall usefulness of BWCs. HPD will continue to participate in these discussions and strive to evolve into a regional leader for BWC programs.

Holding a current accreditation with the Commission for Florida Law Enforcement Accreditation, HPD prides itself in maintaining a strong accreditation team that can evaluate and compile the necessary information using national and regional standards to create effective department policies. The BWC Sergeant, in collaboration with the Facility and Property Manager, Accreditation Team, Senior Management, Middle Management, Union representatives and

assistance from the Broward County State Attorney's Digital Evidence Unit will formulate a policy that meets the standards of both the Department of Justice, The State Attorney's Office, and the Department's vision and goals. As required by this Grant, the policy will also be reviewed and modified in accordance to the technical support team from the Bureau of Justice Assistance. Note: The General Order utilized for the BWC pilot program will be attached in this application.

Department-Wide Deployment: The HPD will begin distribution of the BWCs in a 3stage process. Ist phase of Stage 1: Initially the dayshift officers (approximately 31) will be issued the Axon Body 3 BWC. With the issuance of equipment the officers will attend a minimum of 2 hours training to develop the understanding of how the unit works, and how to properly document and upload its footage. The care and maintenance of the BWC will also be addressed during training. For 30 days the dayshift will utilize the BWC as directed by the established policy. After 30 days it is anticipated that the program road blocks and or issues will have been identified and corrected for the next phase. The 2^{nd} phase of Stage 1 of the deployment will be to the afternoon shift officers (approximately 50). Potentially with the deployment now entering a change in daylight, other potential issues may arise and solutions developed. The final phase 3 of Stage 1 will deploy the BWCs to the midnight shift officers (40). This final phase will test the program and its functionality as customer support teams and other resources readily available during normal business hours will not be available. Stage 2: will consist of deploying the cameras to all other uniformed units that support patrol services and special operations. Such units as our Neighborhood Team Leaders, Beach Unit, Traffic Unit, and School Resource Officers. Stage 3: Officers assigned to the Criminal Investigations Division will be trained and issued BWCs. The Detectives training will be enhanced with the instruction of utilizing the Evidence.com Pro

licensing features, some of which allow access to other agency videos upon request and other features that will aide in investigation.

Impacted Units and Policies

BWC Unit: The purpose of this unit is to provide technical capabilities for the download, upload and storage of captured digital footage. HPD is committed to hiring 3 Digital Evidence Specialist. The civilian specialist will be guided by the Sworn Sergeant who will oversee the public records requests and overall program performance. The redactions and distribution of digital evidence will be in accordance with Florida State Statute 119, also known as the Florida Public Records Act. The costs associated for the hiring, training, and salaries of the civilian employees will be absorbed by the City budget, and have no effect on the funding from this Grant. The requirements and complete job description for these positions are being framed at the time of this application.

Records Unit: The HPD records unit already rigorously follows the directives of this statutes and strives to maintain victim and suspect privacy as dictated by State Law. The HPD Records Unit and standing policy will be modified to work in conjunction with the BWC Unit to provide complete case packages to the State Attorney's Office. In accordance with Florida State Statute 119, the public records requests will be received by the Records Unit and completed by the Digital Evidence Specialist in the BWC Unit. As defined by Florida Statutes and Federal Law, all digital media collected using the BWC will be subject to such laws and definitions.

Response to Resistance: HPDs Response to Resistance, or also commonly known as Use of Force policy will be refined appropriately requiring the submission of any digital evidence captured by the BWC with all submitted reports and will be included in any investigations as required by policy. BWC footage primarily provides evidence for case prosecutions, however a

secondary use will be identifying any training issues, positive or negative and using the information for feedback for the departments Training Unit.

Multiple Department Standard Operating Procedures will be affected by the full scale implementation of BWCs. In accordance with the BJA approved BWC policy provided prior to funding (as required), all subsequent policies will be modified as needed. Some of these polices are: Response to Resistance Criminal Investigations, Internal Affairs, Property and Evidence, Police Records, Public Information Office, Public Records and others.

Capabilities and Competencies

Pillar 3 of the President's Taskforce on 21st Century Policing focuses on the utilization of technology and social media to educate and create partnerships within the communities. The HPD has developed a wide scale technology program that not only assists the agency with investigations, but also provides a wide net of investigation capabilities for the region. The HPD has purchased numerous CCTV units that are strategically positioned throughout the city that provide high definition surveillance of the areas as well as recorded footage. In conjunction with the CCTV, the HPD has purchased multiple, vehicle mounted, trailer mounted, and fixed position License Plate Reading (LPR) cameras that assist both real time and historically with investigations. The HPD has embraced the technology available to Law Enforcement and has been a trend setter in the region for LPR camera deployment. In turn, region wide communication amongst agencies has drastically improved, and information sharing has led to case resolution that once were not possible. Continuing along the technology path, HPD has a vast variety of biometric scanners, Police Records Management Software, and access to State and Federal software designed to assist both the patrol officer and investigator alike. BWCs will only further enhance the ability of HPD

to perform at a high level of legitimacy within the region, and the country. HPD has designed a *Fusion Center* that is staffed by a detective who monitors the cameras, assist in retrieving footage for investigations, and also has an integral role in the continued development of technology hardware and software capabilities. This responsibilities also include the addition of high speed fiber optic data cable to the existing infrastructure, and maintaining its effectiveness with the BWC implementation.

Members of the HPD Command Staff are graduates of the Southern Police Institute of the University of Louisville, and the Federal Bureau of Investigations National Academy. These accolades are not just resume builders, more over an example of HPD's willingness to educate and evaluate itself within the national Law Enforcement community and adopt current trends and ideals. HPD maintains its accreditation standards by conserving relationships throughout the Law Enforcement community, developing a well-rounded, balanced and professional set of policies and practices that are based on factual data, County, State and Federal requirements and meeting the demands of the community. The implementation of BWCs will not only add to the already established credibility with the State Attorney's Office, but will enhance case prosecution by providing compelling audio and digital footage

Program Continuity

HPD command staff and the City of Hollywood Commission are deeply committed to the success of this program and have pledged to dedicate personnel and funding as required for realization of the BWC implementation. During the summer budget workshop for FY22, Commissioners agreed to write in the costs associated with a full implementation BWC program into the FY22 Budget. The Grant funding will supplement those funds by purchasing the hardware and funding the licensing for Evidence.com for 3 years, while the City will fund any additional costs such as personnel, infrastructure improvements, and the continued costs for cloud storage, and any other maintenance costs for the BWCs.

Data Collection

Complaints and Use of Force: Continuing to preserve the recommended practices identified in the *Report of the President's Task Force on 21st Century Policing*, 1.3 states *Law* enforcement agencies should establish a culture of transparency and accountability in order to build public trust and legitimacy. This will help ensure decision making is understood and in accord with stated policy. Thus increased transparency regarding the investigational procedures of the internal complaint process, and the availability of audio and visual digital footage will promote the procedural justice in the complaint process aiding both the officers and the community.

<u>Objective</u>: Improve citizen interactions with officers, and provide an additional tool in determining the outcomes in Use of Force and other complaints.

Criminal Prosecution: In the included letter of support from the Broward County State Attorney's Office, *the presence of BWCs can help strengthen accountability and transparency and can assist in de-escalation of conflicts*. This can result in more constructive interactions between police and the public. In regards to investigation The International Association of Chiefs of Police (IACP) conducted a survey related to the use of video in the judicial process. The study concluded that the presence of video evidence enhanced their ability to obtain convictions, and increased the number of guilty pleas prior to trial. The HPD averages approximately 5,000 arrests per year.

<u>Objective:</u> Capture statements, actions, and evidence during the course of an incident; and enhance officers ability to accurately document an incident for reporting purposes and case development.

Program Evaluation

The HPD Internal Affairs Unit is in charge of investigating complaints against officers, as well as tracking the data of such investigations. The unit analyst will be responsible for compiling the amount of un-sustained allegations against officers for the 3 years of this program, and then comparing those numbers to the prior 3 years without BWCs. Also tracked will be number of officers disciplined as a result of supervisory review of BWC footage and the amount of remedial training recommendations as a result of supervisory review of footage.

The Facilities and Property Manager on coordination with the Lieutenant assigned to the BWC program will routinely survey the officers to gather data useful on performance of both the hardware and software. When feasible officers may be selected to provide survey information regarding their opinions on the program, similar to how the pilot program was conducted. The BWC Sergeant will ensure officers are in compliance with the established BWC policy.

The HPD Records Unit will track all public records requests, and the number of cases presented to the State Attorney's Office that include BWC footage.

The Fiscal Affairs Unit of the HPD will be in charge tracing the financial impact of the BWC program on both the agency budget and the cities general fund.

Closing

The Hollywood Police Department aims to utilize this Body-Worn Camera Project in our overall strategy to achieve stronger partnerships with the community through transparency and accountability, maintain the highest level of officer performance, and continue to be a technological leader in the South Florida region. The award of these Grant funds will ensure the success of the HPD BWC program, and allow HPD to continue to maintain partnerships, solve problems, and implement organizational change in accordance with Community Policing values.
