A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, CHANGING THE REGULAR COMMISSION MEETINGS SCHEDULED IN JULY, OCTOBER AND NOVEMBER 2022, SCHEDULING A REGULAR COMMISSION MEETING ON AUGUST 31, 2022, AND CANCELING THE DECEMBER 21, 2022 AND JANUARY 4, 2023 COMMISSION MEETINGS.

WHEREAS, Section 2.04 of the City's Charter provides, in relevant part, that the City Commission shall schedule no fewer than 20 regular meetings per year and shall hold no fewer than 18 regular meetings per year at such times and places as shall be specified by resolution; and

WHEREAS, pursuant to a series of resolutions, the City Commission has adopted its regular meeting schedule as the first and third Wednesdays of each month starting at 1:00 P.M., except during the month of August; and

WHEREAS, the City Commission desires to add citizens' comments at 5:00 P.M. on the regularly scheduled Wednesday, July 6, 2022 meeting due to moving the July 20, 2023 Commission meeting; and

WHEREAS, the City Commission desires to change the regularly scheduled Wednesday, July 20, 2022 meeting to Wednesday, August 31, 2022, with citizens' comments at 5:00 P.M., to allow more time for next year's fiscal budget preparation; and

WHEREAS, the City Commission desires to change the regularly scheduled Wednesday, October 5, 2022 meeting to Wednesday, October 12, 2022, due to Yom Kippur; and

WHEREAS, the City Commission desires to change the regularly scheduled Wednesday, November 16, 2022 meeting to Wednesday, November 30, 2022, starting at 11:00 A.M., with citizens' comments at 5:00 P.M. due to the Swearing-In Ceremony of the newly elected officials; and

WHEREAS, the City Commission desires to add citizens' comments at 5:00 P.M. on the regularly scheduled Wednesday, December 7, 2022 meeting due to cancelling the December 21, 2022 Commission meeting; and

WHEREAS, the City Commission desires to cancel the regularly scheduled Wednesday, December 21, 2022 meeting due to the holidays; and

WHEREAS, the City Commission desires to cancel the regularly scheduled Wednesday, January 4, 2023 meeting.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That the regular meeting of the City Commission scheduled on July 6, 2022 shall have citizens' comments at 5:00 P.M.

Section 3: That the regular meeting of the City Commission scheduled on July 20, 2022 shall be rescheduled in the City Commission Chambers at City Hall, 2600 Hollywood Boulevard, to Wednesday, August 31, 2022, at 1:00 P.M., with citizens' comments at 5:00 P.M.

Section 4: That the regular meeting of the City Commission scheduled on October 5, 2022 shall be rescheduled in the City Commission Chambers at City Hall, 2600 Hollywood Boulevard, to Wednesday, October 12, 2022, at 1:00 P.M.

Section 5: That the regular meeting of the City Commission scheduled on November 16, 2022 shall be rescheduled in the City Commission Chamber at City Hall, 2600 Hollywood Boulevard, on Wednesday, November 30, 2022, at 11:00 A.M., with citizen's comments at 5:00 P.M.

Section 6: That the regular meeting of the City Commission scheduled on December 7, 2022 shall have citizens' comments at 5:00 P.M.

Section 7: That the regular meeting of the City Commission scheduled on December 21, 2022 shall be cancelled.

Section 8: That the regular meeting of the City Commission scheduled on January 4, 2023 shall be cancelled.

Section 9: Thereafter, regular meetings of the City Commission shall, unless otherwise provided by resolution, be held on the first and third Wednesdays of each month.
