WHEREAS, Hailey Heeranam serves on the Committee as a student member, and her term expires on June 30, 2023; and

WHEREAS, the City Clerk provided notice to the public that positions were available and solicited interest forms from the community to fill the current vacancies; and

WHEREAS, the following individuals have expressed a desire and willingness to fill the vacancies and serve on the Committee:
