A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING AN EXPENDITURE OF LAW ENFORCEMENT FORFEITURE FUNDS TO DEFRAY EXPENSES ASSOCIATED WITH POLICE MANAGEMENT CAREER DEVELOPMENT TRAINING AMOUNT IN THE OF \$50.000.00: AUTHORIZING THE RECOGNITION OF REVENUE AND APPROPRIATION OF NET ASSETS FROM FUND 12 TO BE TRANSFERRED INTO VARIOUS LINE ITEMS AS DETAILED IN THE ATTACHED EXHIBIT 1; AND FURTHER AUTHORIZING THE DEPARTMENT OF FINANCIAL SERVICES TO ESTABLISH ACCOUNT(S) AS MAY BE NEEDED.

WHEREAS, career and leadership training for our police supervisors is essential toward developing an agency's long-term success; and

WHEREAS, establishing a career development training program assists in the development of the future leaders of the Police Department; and

WHEREAS, the completion of advanced police management training, conferences and seminars, which are above and beyond the basic training supervisors receive, have proven to enhance the productivity level and efficiency of a police agency; and

WHEREAS, such training programs are provided by institutes such as the Senior Management Institute for Police, International Association of Chiefs of Police, and the Southern Police Institute; and

WHEREAS, the Department of Financial Services is hereby authorized to create certain accounts and to recognize revenue and appropriate program funding; and

WHEREAS, the expenditure of Law Enforcement Forfeiture Funds to defray the cost of police management career development training will incur no cost to the taxpayers of the City of Hollywood; and

WHEREAS, the Chief of Police recommends that \$50,000.00 be made available from the Law Enforcement Forfeiture Fund to defray expenses associated with police management career development training.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That it hereby approves and authorizes the expenditure of Law Enforcement Forfeiture Funds to defray expenses associated with police management career development training in the amount of \$50,000.00.

<u>Section 2</u>: That is hereby authorizes the Department of Financial Services to create certain accounts and to recognize revenue and appropriate program funding.

<u>Section 3</u>: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
