A RESOLUTION OF THE CITY COMMISSION OF THE CITY  
OF HOLLYWOOD, FLORIDA, APPOINTING TWO  
MEMBERS TO THE SISTER CITIES ADVISORY  
COMMITTEE.

WHEREAS, the City of Hollywood City Commission Sister Cities Advisory Committee ("Committee") was established and approved by Resolution No. R-2023-319, on October 18, 2023, to implement the "Sister City" concept as envisioned by the President of the United States in 1956; and

WHEREAS, the goal of the Committee program is to involve people and organized groups at all levels of society, establishing productive, people-to-people relationships through global community partnerships and volunteer action; and

WHEREAS, the Committee shall consist of five members chosen from the community by a majority vote of the City Commission; and

WHEREAS, members of the Committee shall have an interest in promoting the Sister Cities Program in the City of Hollywood and shall have a strong background in travel or cultural exchange, if possible; and

WHEREAS, four members of the Committee shall be selected at-large, and one member of the Committee shall be a member of the Greater Hollywood Chamber of Commerce; and

WHEREAS, there are two vacant positions due to the resignation of Marcela Rubio who resigned shortly after her appointment, and the removal of Jamil Richards due to two unexcused absences/did not attend any meetings (the Sister Cities Advisory Committee only meets quarterly) in accordance of Section 37.25(B) of the City Code of Ordinance, Uniform Regulations Relating to City Boards; and

WHEREAS, the following individuals have expressed a desire and willingness to serve on the Committee:
