I am writing regarding the hearing tomorrow on the Phillimon Bryan Home, located at 4210 SW 58th Avenue. I have met with the applicant and reviewed the proposed plans for the site, which include the restoration of the Bryan historic property. The Hollywood Historical Society fully supports these restoration efforts.

We were assured that the project will include some form of access to the structure for educational purposes, such as lectures or school groups, as well as opportunities for the public to view the site from the street through the planned opening to the complex. We greatly appreciate this commitment to community engagement.

Our primary concern moving forward is the condition of the structure during the interim period. Since the property is not yet in the applicant's possession, and given that restoration may take some time, we respectfully request that measures be taken to ensure the home does not deteriorate further. Issues such as a leaking roof or the possibility of vandalism could threaten the survival of this delicate and irreplaceable building. We would encourage the City to consider periodic inspections of the property to ensure it remains safe and protected until restoration begins in earnest.
