The Department is in receipt of the Local Agency's (LA) recommendation to award the above referenced project. The bid tabulation documents award to the lowest responsive, responsible bidder. The LA was responsible for the prequalification criteria used for the prospective bidders, with the understanding that the evaluation was based on the contractor's ability to perform the work, experience, personnel, equipment, financial resources, and performance record.

Based on the information provided, FDOT concurs with the LA selection of **AUM Construction** with a total base bid amount of \$1,894,683.00. The low bidder is not suspended or debarred as confirmed with the System of Award Management (https://www.sam.gov/portal/public/SAM/).

Be advised, negotiations with the contractor are not permitted during the award or execution period of the contracting process. Any changes to the contract bid items or quantities must be requested in writing and approved by the Department.

Please provide the Department a copy of the contract between the Local Agency and the Contractor for final review <u>prior</u> to execution. The Local Agency must create the construction contract screens and upload the

executed construction contract in GAP <u>prior</u> to scheduling a pre-construction meeting. All Change Orders must be approved by the Department <u>prior</u> to execution.
