A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE A BLANKET PURCHASE AGREEMENT WITH LOU'S POLICE DISTRIBUTORS, INC. FOR GLOCK 47 FIREARM PACKAGES IN AN ANNUAL AMOUNT UP TO \$100,000.00 OVER A THREE-YEAR PERIOD IN ACCORDANCE WITH SECTION 38.41(C)(9) OF THE PROCUREMENT CODE. (BEST INTEREST)

WHEREAS, the Police Department desires to purchase Glock 47 firearm packages to outfit new and existing sworn law enforcement officers; and

WHEREAS, Glock, Inc. participates in the Blue Label Program that permits law enforcement to purchase firearms at a standardized discounted retail price through a participating distributor; and

WHEREAS, the Police Department has determined that it is in the best interest of the City to purchase Glock 47 firearm packages from Lou's Police Distributors, Inc. ("Lou's") because of its authorized dealer status with Glock, Inc., supply availability, and the vendor's proven reliability to meet the delivery timeline based on prior purchasing experience; and

WHEREAS, the period of performance during which the Glock 47 firearm packages will be acquired is over a three-year period for an annual amount up to \$100,000.00; and

WHEREAS, the amount paid to Lou's will exceed \$100,000.00 for Fiscal Year 2024, and therefore, City Commission approval is required for this purchase pursuant to Section 38.38 of the Procurement Code; and

WHEREAS, Section 38.41(C)(9) of the Procurement Code states that when the City Commission declares by a five-sevenths (5/7^{ths}) affirmative vote that competitive bidding and competitive proposals are not in the best interest of the City, such purchases are exempt from competitive bidding and competitive proposal requirements; and

WHEREAS, the Chief of Police and Interim Chief Procurement Officer recommend that the City Commission authorize the execution of a Blanket Purchase Agreement with Lou's for Glock 47 firearm packages in an annual amount up to \$100,000.00; and

WHEREAS, funding for the Blanket Purchase Agreement is available in account number 112.209803.52100.540030.001521.000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it authorizes the execution, by the appropriate City officials, of a Blanket Purchase Agreement with Lou's, together with such non-material changes as may subsequently be agreed to by the City Manager and approved as to form by the City Attorney.

<u>Section 3</u>: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
