A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE AN AUTHORIZATION TO PROCEED WITH ATKINS NORTH AMERICA, INC. TO PROVIDE PROFESSIONAL ENGINEERING CONSULTING SERVICES FOR PHASE II OF THE TRAFFIC CALMING PROGRAM IN AN AMOUNT NOT TO EXCEED \$166,368.00.

WHEREAS, in March of 2019, the voters passed the General Obligation Bond, which included provisions to set funding aside in the amount of \$2,189,119.00 for the establishment of a Traffic Calming Program ("Program") to address safety concerns raised by residents regarding vehicular speeding and cut-through traffic in their neighborhoods; and

WHEREAS, Atkins North America, Inc. ("Atkins") and the City currently have a continuing Professional Services Agreement for civil, landscape, architecture, planning and engineering services for future roadway and complete streets projects, which was approved by the City Commission pursuant to Resolution No. R-2018-400; and

WHEREAS, on March 4, 2020, City Commission passed and adopted Resolution No. R-2020-56 authorizing the appropriate City officials to issue an Authorization to Proceed to Atkins to provide professional engineering services for the establishment of a Citywide Traffic Calming Program; and

WHEREAS, Atkins has completed the initial scope of work to prioritize the proposed locations for various traffic calming elements Citywide, which is to be included in the preparation of conceptual plans for construction; and

WHEREAS, the Division of Engineering, Transportation and Mobility has determined that additional professional engineering services are needed to develop the next phase of the traffic calming program that would focus on the preparation of conceptual plans for construction; and

WHEREAS, the Division of Engineering, Transportation and Mobility staff requested a proposal from Atkins to provide professional engineering services to facilitate the next phase of the Program; and

WHEREAS, the total fees relating to this phase of the project is in an amount not to exceed \$166,368.00; and

WHEREAS, the Director of the Development Services and the City Engineer recommend that the City Commission authorize the appropriate City officials to issue an Authorization to Proceed with Atkins for the next phase of the traffic calming project as outlined in Atkins proposal in an amount not to exceed \$166,368.00; and

WHEREAS, funding for this project was included in the amended FY 2021 Capital Improvement Plan and is available in account number 333.149901.54100.563010.001185.000.000.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and incorporated in this Resolution.

Section 2: That it approves and authorizes the issuance, by appropriate City officials, of the attached Authorization to Proceed with Atkins North America, Inc., together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
