A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, CHANGING THE REGULAR COMMISSION MEETINGS SCHEDULED IN JULY 2018, SCHEDULING A REGULAR COMMISSION MEETING ON AUGUST 29, 2018, CHANGING THE SECOND REGULAR COMMISSION MEETING SCHEDULED IN SEPTEMBER 2018 AND NOVEMBER 2018, AND CANCELLING THE JANUARY 2, 2019 COMMISSION MEETING.

WHEREAS, Section 2.04 of the Charter of the City of Hollywood provides, in relevant part, that the City Commission shall meet regularly not less than 20 times during the calendar year, at such times and places as shall be specified by Resolution; and

WHEREAS, pursuant to a series of resolutions, the City Commission has adopted its regular meeting schedule as the first and third Wednesdays of each month starting at 1:00 PM, except during the month of August; and

WHEREAS, the City Commission desires to change the regularly scheduled Wednesday, July 4, 2018 meeting to Tuesday, July 3, 2018 with citizens' comments at 5:00 PM due to the Fourth of July Holiday; and

WHEREAS, the City Commission desires to change the regularly scheduled Wednesday, July 18, 2018 meeting to Wednesday, August 29, 2018 with citizens' comments at 5:00 PM for allow more time for next year's fiscal budget preparation; and

WHEREAS, the City Commission desires to change the regularly scheduled Wednesday, September 19, 2018 meeting to Thursday, September 20, 2018 with citizens' comments at 5:00 PM due to the Yom Kippur Holiday; and

WHEREAS, the City Commission desires to change the regularly scheduled Wednesday, November 21, 2018 meeting to Tuesday, November 20, 2018 starting at 11:00 AM, with citizens' comments at 5:00 PM due to the Swearing In Ceremony of the newly elected officials; and

WHEREAS, the City Commission desires to cancel the regularly scheduled Wednesday, January 2, 2019 meeting;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the regular meeting of the Hollywood City Commission scheduled on July 4, 2018 shall be rescheduled in the City Commission Chamber at City

Hall, 2600 Hollywood Boulevard, on Tuesday, July 3, 2018 at 1:00 PM, with citizen's comments at 5:00 PM.

Section 2: That the regular meeting of the Hollywood City Commission scheduled on July 18, 2018 shall be rescheduled in the City Commission Chamber at City Hall, 2600 Hollywood Boulevard, to Wednesday, August 29, 2018 at 1:00 PM, with citizens' comments at 5:00 PM.

Section 3: That the regular meeting of the Hollywood City Commission scheduled on September 19, 2018 shall be rescheduled in the City Commission Chamber at City Hall, 2600 Hollywood Boulevard, on Thursday, September 20, 2018 at 1:00 PM, with citizen's comments at 5:00 PM.

Section 4: That the regular meeting of the Hollywood City Commission scheduled on November 21, 2018 shall be rescheduled in the City Commission Chamber at City Hall, 2600 Hollywood Boulevard, on Tuesday, November 20, 2018 at 11:00 AM, with citizen's comments at 5:00 PM.

Section 5: That the regular meeting of the Hollywood City Commission scheduled for January 2, 2019 shall be cancelled.

Section 6: Thereafter, regular meetings of the City Commission shall, unless otherwise provided by Resolution, be held on the first and third Wednesdays of each month.

Section 7: That this resolution shall be in full force and effect immediately upon its passage and adoption.
