A RESOLUTION OF THE CITY COMMISSION OF THE CITY  
OF HOLLYWOOD, FLORIDA, APPOINTING FIVE MEMBERS  
TO THE YOUNG CIRCLE ARTSPARK ADVISORY BOARD.

WHEREAS, the City's Young Circle ArtsPark Advisory Board ("Board") was created in 2006 by Resolution No. R-2006-412, and revised by Resolution Nos. R-2007-48 and R-2013-199 that changed the composition of the Board to nine voting members, with two non-voting appointed representatives and two non-voting ex-officio members; and

WHEREAS, the two non-voting appointed representatives include one from Broward County Cultural Affairs Division and one from the Broward County Cultural Affairs Council, and the two non-voting ex-officio members are the City Manager appointee and the ArtsPark Foundation appointee; and

WHEREAS, there are currently eight voting members who serve in the following categories: (1) Visual Arts Field; (2) Performing Arts Field; (1) Extensive Art & Culture Background – Hollywood Resident; (1) Arts Community At Large; (1) Broward County School System; and (3) Citizen-at-Large – Hollywood Residents; and

WHEREAS, Board members are appointed based upon their interest in the arts and culture and backgrounds in the categories of visual arts, performing arts, tourism, arts community-at-large, education, and a resident with extensive art and culture background; and

WHEREAS, the purpose of the Board is to make recommendations to the City Commission on the operational management structure, proposed facility modifications, and programming of the ArtsPark; and

WHEREAS, there are five vacancies created by term expiration of Jeniffer Bello, Performing Arts Field, whose term expires on June 30, 2024; Cathleen Dean, Extensive Art and Culture Background – Hollywood Resident, whose term expires on June 30, 2024; Jill Weisberg, Arts Community Large, whose term expires on June 30, 2024; Elle Pagliano, Broward County School System, whose term expires on June 30, 2024; and Luis Villamizar, Citizen-at-Large-Hollywood Resident, whose term expires on June 30, 2024; and

WHEREAS, the City Clerk provided notice to the public that positions were available and solicited interest forms from the community to fill the current vacancies; and

WHEREAS, the following individuals have expressed a desire and willingness to fill the vacancies and serve on the Board:
