City Manager's approval of an Authorization to Proceed for EAC Consulting,

Inc. in the Amount of \$76,060.56

Issue:

City Manager' approval is required prior to the issuance of an Authorization to Proceed (ATP) to EAC Consulting, Inc.

EXPLANATION:

Lift Station A-09 conveys sewer from the residents of the Boulevard Heights neighborhood to the City's sanitary sewer trunk main line through a 10" asbestos forcemain along N. 70 Avenue, from Johnson St. to Arthur St. This section of forcemain has reached the end of its useful life as evidenced by breaks in recent years. It has been in service since 1958, and its replacement is necessary to provide continuous reliable sanitary sewer service to residents of the neighborhood. The Department contacted EAC Consulting, Inc. to provide design services for replacement of the forcemain.

EAC Consulting, Inc. and City of Hollywood have an existing Professional Services Agreement for General Engineering Consulting Services for water, sewer, reuse and stormwater infrastructure projects approved by City Commission Resolution No. R-2017-284, dated, September 20, 2017.

The Department determined that the proposal meets the needs of the City and that the Department's staff will manage this project, which is expected to last for approximately three months. No additional staff is needed as a result of this project.
