COMMUNITY OUTREACH SUMMARY

Dear Cameron

On behalf of MMVJ LAND LLC (“Applicant”), please consider this letter as a summary of community outreach efforts undertaken in relation to proposed land use plan amendment application 22-DP-42.

The above-mentioned development has been submitted as an “as-of-right” development, and no variances and/or land use amendments were requested in pursuit of the city site plan approval.

While a new public virtual meeting has been scheduled for the 5th of September another meeting had happened, where the project was presented in front of the Park Side Civic Association, this meeting was held on May 4th, 2022. During said meeting, the project was presented and received positive feedback from the association. They expressed two main concerns. One, regarding the previous color of the building, when the exterior was proposed to be painted on an “range/red” brick, they suggested to be replaced with a lighter and maybe on the tones of grey. The other suggestion was to try to incorporate additional amenities into the building.

After the analysis of these requests with the applicant, we were able to address one of their concerns, the one related to the color of the building and the new color (shown in this presentation) is the one proposed in response to their concern. Everything else, proposed on the design was positively taken by them. Please, refer to attached letter of recommendation submitted by the association after the meeting.

Parkside Civic Association had a meeting with the developers of 2005 Jackson Street located in Parkside. We do approve of the overall design of the building with the architectural detail on the cornice of the building, ground floor apartments and yards, landscaping and features around the building.

However, we did suggest that they investigate roof amenities such as pool or hot tub, grill areas, covered room seating, etc. We felt that the similar buildings of this scale are in fact doing so and that it makes Parkside and the City more appealing. However, they chose not to do so. Again, these ideas were *suggestions*.

We do strongly suggest that the color of the building be revisited because of a couple points.

- 1) The dark color is more of a "Southwest or "Mediterranean" style and not indicative of Hollywood or the modern South Florida color scheme.
- 2) The dark color will most likely be a maintenance issue due to the harsh Florida sun which bleaches out darker colors. You can easily see this on our murals throughout the city which I may add, are need of repainting due to this effect. We are concerned that the upkeep may be lax, thusly leaving us with a building that looks not to par with the city standards.

Overall, Parkside Civic Association is excited about 2005 and look forward to it joining our neighborhood.





HOLLYWOOD LAND USE MAP







2ND FLOOR PLAN






