## 1.0 Summary

The City of Hollywood ("City") has requested program management services to provide leadership, overall management, and direction for the completion of the GOB projects, CIP projects, and other projects outside the GO program on an as-needed basis. We understand that the requested services will be contracted starting June 23, 2025.

## 2.0 Scope Of Work

Scope of Work for Program Management of GOB CIP and Other City Projects

#### 1. Overview:

Barr&Barr proposes the assignment of a Program Management Director and an Executive level project manager to provide overall leadership, oversight, and direction of the City of Hollywood GOB, CIP, and other City-related projects. The individual(s) will serve as strategic and implementation leaders to ensure the City's CIP projects under the Design and Construction Management Department are executed successfully and meet defined objectives, timelines, and budgets. These resources will be pivotal in personnel management, risk management, contract execution, and budget preparation for City projects.

## **Key Responsibilities of the Program Director (Jose Cortes):**

- Administers the City's Design and Construction management projects and programs; directs through subordinates the planning, scheduling, and coordination of Department activities; develops policies, procedures and priorities to meet established goals.
- Guides and directs the implementation of the City's Capital Improvement program to ensure efficient utilization of department resources for the design, construction and renewal of facilities.
- Presents Capital Improvement plans and accomplishments to senior management and the City Commission.
- Oversees review and evaluation of plans for proposed projects.
- Plans, assigns, directs and evaluates the work of assigned subordinates.
- Provides operational, administrative and regulatory assistance; develops procedures for solving technical problems; reviews and presents capital improvement operating budgets; and prepares cost estimates for complex projects.
- Meets with the public and developers to discuss the City's Capital Improvement Projects.
- Oversees the preparation of construction estimates for proposed City projects and maintains records during construction
- Oversees the review and approval of construction plans prepared by consulting engineers and architects.
- Interacts with regulatory agencies; makes technical presentations to regulators and negotiates appropriate solutions to existing or emerging problems; coordinates, organizes, plans and budgets long-term compliance with regulatory mandates.
- Processes grievances and discipline, conducts employee performance evaluations, interviews and makes
  recommendations regarding hiring to senior management, approves salary increases and promotions and
  authorizes leave and overtime.
- Develops and administers the Department's budget.
- Serves as an advisor to the City Manager's Executive Management Team.
- Responds to complaints from citizens related to department projects.
- Attends and represents the department at commission meetings and other department meetings.
- Assists in Emergency Operations on behalf of the Department, including preparations, during and postevent.
- Effectively and positively represents the City in delivering and performing work with colleagues and clients, irrespective of gender, race, religion, age, disability, political affiliation or belief, or sexual orientation.
- Establishes and maintains effective and professional relationships with internal and external stakeholders.
- Performs related work as required. Oversee the progress of GOB, CIP and other City projects, ensuring alignment with strategic goals.
- Attend regular meetings with project managers (PMs) to review the status, challenges, and


opportunities of key projects.
