- FY 15 amount is the funding remaining from the Seminole Contract received in FY 15. Annual contract amount to be received for the last two years of the Seminole Contract will be \$300,000 annually less funding commitments to date in FY 2016. FY 2015 funding is part of the Special Programs Fund (11) rollover request.
- The funding of \$150,000 is the Fire Department portion of the \$450,000 Public Safety Vehicle Replacement Capital Project approved as part of the FY 2016 - FY 2020 Capital Improvement Plan per Resolution R-2015-295 on September 28, 2015.
- This funding will become available subject to the approval of a companion resolution on the November 18, 2015 City Commission agenda to approve the reauthorization, re-appropriation, and rollover of previously approved FY 2015 capital projects and special program funds.
- Funding for the lease purchase costs beyond FY 2017 assumes the continuation of the existing contract for capital expenditures with the Seminole Tribe which is scheduled to expire in October 2017.
- Funding needed as a cash funding match by the City as required for the FEMA and Department of Homeland Security's (DHS), Staffing for Adequate Fire and Emergency Response, SAFER, grant and the DHS' Assistance to Firefighters' Grant, AFG, may not be available due to funding commitments associated with the lease purchase of the Firefighters Grant, AFG, may not be available due to funding commitments associated with the lease purchase of the Fire Rescue ALS vehicles and the Fire Pumper Truck.
