As consulting engineers for the City of Hollywood Department of Public Utilities, on June 6, 2017 Kimley-Horn completed its review of the bid package submitted for the above referenced Public Utilities project by Metro Express, Inc. (MEI), which was found to be the low bidder. However, based on the qualifications criteria established by the City, insufficient information was provided in the bid package to determine whether MEI had the experience, technical and/or financial ability, and met all other qualifications to satisfactorily complete a project of this nature and magnitude. In accordance with Part 10 of Section 00100, "Instructions to Bidders", on June 8, 2017 Kimley-Horn forwarded a written request to MEI, giving them an opportunity to present additional evidence before final action was taken. On June 15, 2017, MEI submitted a response to the information requested below via email (copy attached). Kimley-Horn's comments regarding their responses are provided next to each category below, and all submitted documentation is attached for your review:

- 1) Evidence of at least three (3) projects similar in nature and magnitude to Project 14-5122 that were completed by MEI within the last seven (7) years (on or after June 1, 2010):

 <u>Comments:</u> No documentation was found in the response package to support MEI's similar project experience within the last seven (7) years.
- 2) Proof of experience with public outreach by providing information for a minimum of three (3) similar projects on which MEI performed these services within the last seven (7) years:

 <u>Comments:</u> MEI provided a general Public Outreach Statement and a list of four (4) projects. There is no indication of whether these projects were performed by MEI or by



MEI staff while under prior employment, no contract amounts to confirm if the projects were of similar magnitude to 14-5122, and no descriptions of activities undertaken.

3) Resumes for both the Project Superintendent and the Project Manager, each including a minimum of two (2) similar projects managed by him/her which were completed within the last seven (7) years.

<u>Comments:</u> Resumes were provided for Project Manager Adrian Othon and Superintendent Jorge Oliveros, each with three projects. All of Mr. Oliveros' experience appears to have been while employed as an inspector with the Miami-Dade Water and Sewer Department, and not as superintendent with a contractor.

4) Provide proof of equipment ownership.

<u>Comments:</u> The documentation provided appears to meet the qualification requirement

Given the contents of MEI's bid response package and subsequent documentation provided herein, and based on the evaluation criteria established by the City of Hollywood for Water Main Replacement Project 14-5122, it is Kimley-Horn's opinion that, as a firm, MEI does not meet the qualifications and criteria established by the City of Hollywood for selection under this contract.

Please provide the following information for at least three (3) projects similar in nature and magnitude to Project 14-5122 that were completed by MEI within the last seven (7) years (on or after June 1, 2010). Each project must be from a separate contract:
 - a) Project name, Client name, City and location
 - b) Project description
 - c) Was it completed by the bidding firm or with a prior firm
 - d) Provide names, phone numbers and/or email addresses for verifiable references
 - e) Date construction was completed
