A RESOLUTION OF THE CITY COMMISSION OF THE CITY **APPROVING** OF HOLLYWOOD. FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE A BLANKET PURCHASE AGREEMENT WITH CONCRETE WORKS & PAVING INC. FOR RESURFACING, SIDEWALK AND OTHER **MISCELLANEOUS** CONSTRUCTION SERVICES IN AN AMOUNT NOT TO **EXCEED** \$3,000,000.00 BASED **UPON BROWARD** COUNTY'S RFQ NO. PNC2123416B1 IN ACCORDANCE WITH SECTION 38.41(C)(5) THE OF CITY'S PROCUREMENT CODE (PIGGYBACK).

WHEREAS, the City's current Capital Improvement Program includes Sidewalk Infill Projects to install new sidewalks along various streets within the City as well as resurfacing of various roads and alleys Citywide; and

WHEREAS, in order to implement these projects, the Department of Development Services Engineering, Transportation and Mobility Division desires to retain a company to perform the required construction services; and

WHEREAS, the desired services were competitively bid by Broward County pursuant to RFQ No. PNC2123416B1 ("RFQ") on December 8, 2021, and the current term of the contract is from March 21, 2022 through March 20, 2023, with an option to renew the contract for up to two additional one-year terms; and

WHEREAS, Broward County awarded the bid to Concrete Works & Paving, Inc. ("Concrete Works"), and Concrete Works has agreed to extend to the City the same pricing under the terms and conditions set forth in Broward County's RFQ and contract; and

WHEREAS, Section 38.41(C)(5) of the City's Procurement Code allows the Chief Procurement Officer to procure, without formal solicitation procedures, all goods, supplies, materials, equipment, and services that are the subject of contracts with the state, its political subdivisions, the United States government, other governmental entities, or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof ("piggyback"), provided that the goods, supplies, materials, equipment, or services are the subject of a price schedule negotiated by the entities listed above and is based strictly on competitive bids, quotations, or competitive proposals and not on any preference and such utilization of other governmental entities contracts shall be permitted only during the term of the other governmental entity's contract; and

WHEREAS, the project's estimated cost will not exceed \$3,000,000.00; and

WHEREAS, the Director of Development Services, the City Engineer and the Chief Procurement Officer recommend that the City Commission approve the execution of the attached Blanket Purchase Agreement with Concrete Works based upon Broward County's RFQ to provide sidewalk construction services for the sidewalk corridors projects pursuant to the Fiscal Year 2021-22 Sidewalk Corridors; and

WHEREAS, funding for this project was included in the amended FY 2022 Capital Improvement Plan, and is available in account numbers 336.149901.54100.563010.001279.000.000 and 116.160502.51900.583440.001247.000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it approves and authorizes the execution, by the appropriate City officials, of the attached Blanket Purchase Agreement with Concrete Works & Paving, Inc., together with such non-material changes as may subsequently be agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
