A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, CHANGING THE REGULAR COMMISSION MEETINGS SCHEDULED IN JULY 2017, SCHEDULING A REGULAR COMMISSION MEETING ON AUGUST 30, 2017, CHANGING THE REGULAR COMMISSION MEETING SCHEDULED IN DECEMBER 2017, AND CANCELLING THE JANUARY 3, 2018 COMMISSION MEETING.

WHEREAS, the City Commission desires to change the regularly scheduled Wednesday, July 5, 2017 meeting to Monday, July 3, 2017 with citizens' comments at 5:00 PM; and

WHEREAS, the City Commission desires to change the regularly scheduled Wednesday, July 19, 2017 meeting to Wednesday, August 30, 2017 with citizens' comments at 5:00 PM; and

WHEREAS, the City Commission desires to cancel the regularly scheduled Wednesday, December 20, 2017 meeting; and

WHEREAS, the City Commission desires to have citizens' comments at the Wednesday, December 6, 2017 meeting at 5:00 PM, since the Wednesday, December 20, 2017 meeting will be cancelled; and

WHEREAS, the City Commission desires to cancel the regularly scheduled Wednesday, January 3, 2018 meeting;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the regular meeting of the Hollywood City Commission scheduled on July 5, 2017 shall be rescheduled in the City Commission Chamber at City Hall, 2600 Hollywood Boulevard, to Monday, July 3, 2017 at 1:00 PM, with citizen's comments at 5:00 PM.

<u>Section 2</u>: That the regular meeting of the Hollywood City Commission scheduled on July 19, 2017 shall be rescheduled in the City Commission Chamber at City Hall, 2600 Hollywood Boulevard, to Wednesday, August 30, 2016 at 1:00 PM, with citizens' comments at 5:00 PM.

<u>Section 3</u>: That the regular meeting of the Hollywood City Commission scheduled on December 6, 2017 at 1:00 PM will have citizen's comments at 5:00 PM.

<u>Section 4</u>: That the regular meeting of the Hollywood City Commission scheduled for December 20, 2017 shall be cancelled.

<u>Section 5</u>: That the regular meeting of the Hollywood City Commission scheduled for January 3, 2018 shall be cancelled.

<u>Section 6</u>: Thereafter, regular meetings of the City Commission shall, unless otherwise provided by Resolution, be held on the first and third Wednesdays of each month.

<u>Section 7</u>: That this resolution shall be in full force and effect immediately upon its passage and adoption.
