A RESOLUTION OF THE CITY COMMISSION OF THE CITY THE HOLLYWOOD. FLORIDA, AUTHORIZING APPROPRIATE CITY **OFFICIALS** THE TO ISSUE ATTACHED BLANKET PURCHASE ORDERS BETWEEN THE FOLLOWING SIX (6) VENDORS: DIAMOND R. FERTILIZER. SITEONE LANDSCAPE SUPPLY RESIDEX LLC, HELENA CHEMICAL COMPANY, HOWARD FERTILIZER COMPANY, INC., AND HARRELL'S LLC AND THE CITY OF HOLLYWOOD FOR THE SUPPLY OF VARIOUS FERTILIZERS AND RELATED CHEMICALS FOR A COMBINED ANNUAL AMOUNT NOT TO EXCEED \$73,000.00.

WHEREAS, the Department of Public Works and the Department of Parks, Recreation & Cultural Arts, require an agreement with a qualified vendor for the purchase of various fertilizers and related chemicals used in the normal maintenance of turf grasses and landscaped areas; and

WHEREAS, the required commodities were competitively bid by the Town of Davie, Florida Bid Number B-17-124, acting as the lead agency for the Southeast Florida Governmental Purchasing Group Cooperative, and awarded to Diamond R Fertilizer, SiteOne Landscape Supply, LLC, Residex, LLC, Helena Chemical Company, Howard Fertilizer, Inc., and Harrell's, LLC for an initial three (3) year period beginning on August 17, 2017 and ending on August 16, 2020, with no renewal options; and

WHEREAS, Section 38.46 of the City of Hollywood Code of Ordinances provides that the Director shall have the authority to join with other governmental entities in cooperative purchasing plans when the best interests of the city would be served thereby; and

WHEREAS, the Director of Public Works, the Director of Parks, Recreation & Cultural Arts, and the Director of Procurement & Contract Compliance recommend that the City Commission approve the issuance of the attached blanket purchase orders to Diamond R Fertilizer (\$2,500.00), SiteOne Landscape Supply LLC (\$5,000.00), Residex LLC (\$25,000.00), Helena Chemical Company (\$25,000.00), Howard Fertilizer, Inc.(\$6,500.00), and Harrell's LLC (\$9,000.00) for the purchase of various fertilizers and related chemicals used in the normal maintenance of turf grasses and landscaped areas for the City's Department of Public Works (\$36,000.00) and Department of Parks, Recreation & Cultural Arts (\$37,000.00), for an initial period ending on August 16, 2020 with no renewal options for an estimated annual expenditure of \$73,000.00; and

WHEREAS, award is subject to the City's receipt and approval of all insurance certificates required by the City's Risk Manager; and

WHEREAS, funding has been provided in the fiscal year 2017 budget in the Department of Parks, Recreation & Cultural Arts Account Number 01.3169.00417.572.005235 and the Department of Public Works Account Numbers 01.5171.00481.541.005233 and 01.5171.00483.541.005235, and funding will be budgeted in subsequent fiscal years;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:
