A RESOLUTION OF THE HOLLYWOOD, FLORIDA COMMUNITY REDEVELOPMENT AGENCY (“CRA”), AUTHORIZING THE APPROPRIATE CRA OFFICIALS TO EXECUTE A SECOND AMENDMENT RENEWING THE CLEAN AND SAFE AMBASSADOR PROGRAM AGREEMENT WITH MYDATT SERVICES, INC., D/B/A BLOCK BY BLOCK, IN AN ANNUAL AMOUNT UP TO \$600,652.40.

WHEREAS, on December 5, 2018, the CRA Board passed and adopted Resolution No. R-CRA-2018-053, which authorized the Hollywood, Florida Community Redevelopment Agency (“CRA”) to execute an Agreement for a Clean and Safe Ambassador Program (“Agreement”) with Mydatt, Inc., d/b/a Block By Block (“Mydatt”); and

WHEREAS, on January 29, 2019, the parties executed an Agreement with an initial term of three years and two additional two-year renewal periods; and

WHEREAS, on April 6, 2022, the CRA Board passed and adopted Resolution No. R-CRA-2022-09, authorizing the CRA to execute an amendment for the first two-year renewal period expiring on January 28, 2024; and

WHEREAS, the cost of the first year of this second renewal period is an estimated annual amount up to \$586,034.73, and the cost of the second year is an estimated amount up to \$600,652.40; and

WHEREAS, the second and final renewal term will expire on January 28, 2026; and

WHEREAS, CRA staff has determined that it is in the best interest of the CRA to renew the Agreement for the second and final two-year term; and

WHEREAS, Mydatt has agreed to the renewal under the same terms and conditions; and

WHEREAS, the Clean and Safe Ambassador Program provides services to Downtown Hollywood that include but are not limited to litter abatement, graffiti removal from public property, special projects such as painting of safety zones and lightpole bases, after hour emptying of trash receptacles, distribution of information to business owners and patrons, and assistance with special events as needed; and

WHEREAS, the Executive Director recommends the execution of the second amendment renewing the Agreement with the Contractor for the Clean and Safe Ambassador Program for the second and final two year term; and

WHEREAS, funding for this project has been provided in the Fiscal Year 2024 budget in account number 166.668602.55200.552010.000000.000.000, and will be appropriated in subsequent fiscal years.

NOW, THEREFORE, BE IT RESOLVED BY THE HOLLYWOOD, FLORIDA COMMUNITY REDEVELOPMENT AGENCY:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it authorizes appropriate CRA officials to execute a second amendment renewing the Clean and Safe Ambassador Program Agreement with Mydatt Services, Inc., d/b/a Block By Block, together with such non-material changes as may be subsequently agreed to by the Executive Director and approved as to form by CRA General Counsel.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
