A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO NEGOTIATE AND EXECUTE A FRANCHISE AGREEMENT BETWEEN FLSC, LLC. AND THE CITY OF HOLLYWOOD TO PROVIDE A TEXTILE RECYCLING AND COLLECTION SERVICES PROGRAM IN THE CITY OF HOLLYWOOD.

WHEREAS, on November 15, 2017, the City Commission passed and adopted Ordinance No. PO-2017-21, which approved the establishment of a textile recycling collection services program throughout the City; and

WHEREAS, the Police Department desires a franchise agreement for a qualified firm to handle the textile recycling collection services program in accordance with Chapter 109 of the City of Hollywood Code of Ordinances; and

WHEREAS, textile recycling collection bins will allow members of the general public to deposit used textile items such as shoes, clothing, linens and draperies for either the purpose of resale or re-used for other purposes; and

WHEREAS, the textile recycling services program is available through FLSC, LLC. pursuant to the Town of Davie, Florida, Bid Number B-14-92, which was procured by a competitive bid process; and

WHEREAS, Section 38.40 (C)(5) of the Purchasing Ordinance allows the Director to procure, without following formal procedures, all goods and services which are subject of contracts with the state, its political subdivisions, the United States government, other governmental entities, or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof, provided however, the goods and services are: (i) the subject of a price schedule negotiated by the state or the United States government, or (ii) the subject of a contract with another governmental entity or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof, which contract is based strictly on competitive bids or competitive proposals and not on any preference; and

WHEREAS, the Acting Chief of Police and the Director of Procurement and Contract Compliance recommend that the appropriate City Officials negotiate and execute a franchise agreement with FLSC, LLC. to provide the textile recycling services program in accordance with Chapter 109 of the City of Hollywood Code of Ordinances;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That it hereby approves and authorizes the appropriate City Officials to negotiate and execute a franchise agreement between FLSC, LLC. and the City of Hollywood, in form acceptable to the City Manager and approved as to form and legality by the Acting City Attorney.

Section 2: That this resolution shall be in full force and effect immediately upon its passage and adoption.
