A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE A CONTRACT WITH SOUTHERN UNDERGROUND INDUSTRIES, INC. FOR CONSTRUCTION SERVICES RELATED TO THE REPLACEMENT OF THE HALLANDALE BEACH FORCE MAIN AND LARGE USER METER LUM-07 PROJECT IN THE AMOUNT OF \$1,974,652.44; APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE AN AUTHORIZATION TO PROCEED FOR WORK ORDER NUMBER TTH 21-01 WITH TETRA TECH, INC. TO PROVIDE PROFESSIONAL ENGINEERING SERVICES FOR ADDITIONAL DESIGN AND CONSTRUCTION ADMINISTRATION FOR THIS PROJECT IN THE LUMP SUM AMOUNT OF \$85,858.00.

WHEREAS, the Southern Regional Wastewater Treatment Plant serves six large users, including the City of Hallandale Beach; and

WHEREAS, one of the City of Hallandale Beach's sewer flow connections is through the large user meter LUM-07 and the existing force main along South 19th Avenue, Plunket Street and South 15th Avenue, which consists of 8-inch and 10-inch diameter piping installed in 2001; and

WHEREAS, the capacity of the existing force main and the large user meter is not large enough to meet the current and future sewer flowrate from the City of Hallandale Beach, and thus, the system must be upsized; and

WHEREAS, on March 6, 2019, pursuant to Resolution R-2019-039, the City Commission authorized the execution of an Authorization to Proceed for Work Order No. TTH 19-01 with Tetra Tech, Inc. ("Tetra"), in the amount of \$147,917.00, to provide professional engineering services for the design, permitting and bidding services for the Replacement of the Hallandale Beach Force Main and Large User Meter LUM-07 project; and

WHEREAS, on September 29, 2020, the Department of Public Utilities staff advertised the project, soliciting for qualified construction services, and on December 22, 2020, 11 bid proposals were received at the Office of the City Clerk and were publicly opened at the City's Southern Regional Wastewater Plant with the following results:

WHEREAS, after thoroughly evaluating the bid proposals for compliance with the contract documents, Tetra's staff determined that the low bidder, Southern Underground Industries, Inc., is the lowest responsive, responsible bidder; and

WHEREAS, on January 4, 2021, a Notice of Intent to Award related to the project was posted on the City of Hollywood's website and on DemandStar and resulted in no bid protests; and

WHEREAS, Tetra and the City have a continuing Professional Services Agreement for General Engineering Consulting Services for water, sewer, reuse and stormwater infrastructure projects, approved by the City Commission pursuant to Resolution No. R-2017-284 on September 20, 2017; and

WHEREAS, the Department of Public Utilities staff requested a proposal from Tetra Tech, Inc. to provide additional design and construction administration services for the project; and

WHEREAS, Tetra Tech, Inc. submitted a proposal to provide additional design and construction administration services in the lump sum amount of \$85,858.00; and

WHEREAS, the Department of Public Utilities recommends the City Commission approve and authorize the appropriate City officials to execute the attached contract with Southern Underground Industries, Inc. in the amount of \$1,974,652.44, and to execute the attached Authorization to Proceed for Work Order No. TTH 21-01 with Tetra Tech, Inc. for additional design and construction administration services in the lump sum amount of \$85,858.00; and

WHEREAS, funding was included in the amended FY 2021 Capital Improvement Plan and is available in account number 442.409901.53600.531210.001140.000.000 and 442.409901.53600.563010.001140.000.000; and

WHEREAS, the estimated time for completion of construction is 274 calendar days from the Notice to Proceed date.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the execution, by the appropriate City officials, of the attached Contract with Southern Underground Industries, Inc., together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 3: That it approves and authorizes the execution, by the appropriate City officials, of the attached Authorization to Proceed for Work Order No. TTH 21-01 with Tetra Tech, Inc., together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 4: That this Resolution shall be in full force and effective immediately upon its passage and adoption.
