A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, SUPPORTING THE STATE ROAD 7 CORRIDOR BIKE/MOBILITY IMPROVEMENT PROJECT LOCATED ALONG TAFT STREET FROM SR-7 TO NORTH 40TH AVENUE AND ACKNOWLEDGING THE CITY'S OBLIGATION TO MAINTAIN THE BIKE/MOBILITY IMPROVEMENTS WITHIN THE CITY'S RIGHTS-OF-WAY.

WHEREAS, in July 2016, the Florida Department of Transportation ("FDOT") and Broward Metropolitan Planning Organization ("MPO") completed the SR-7 Multimodal Improvement Corridor Study that analyzed first and last mile connections for multimodal improvements along various side streets to the SR-7 transit corridor; and

WHEREAS, construction of bike/mobility improvements along Taft Street from SR-7 to North 40th Avenue were identified in this study; and

WHEREAS, the MPO has received federal funding for this project and the project will be administered by FDOT through its completion; and

WHEREAS, FDOT has been authorized to undertake a project identified as Financial Project #429576-9 within Broward County's geographical limits, to provide bike/mobility improvements along Taft Street from SR-7 to North 40th Avenue; and

WHEREAS, the City supports the installation of these improvements and is willing to maintain the bike/mobility improvements within its right-of-way after the installation is completed; and

WHEREAS, FDOT is planning to advertise for the design of the project and is requesting that the City Commission adopt a Resolution in support of the project.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it supports the State Road 7 Corridor bike/mobility improvement project located along Taft Street from SR-7 to North 40th Avenue.

Section 3. That it acknowledges the City's obligation to maintain the Taft Street bike/mobility improvements within the City's rights-of-way from SR-7 to North 40th Avenue upon completion of said improvements.
